### **Membership/Lapsation**

#### WINNING COMBINATION

Multiple rewards abound with membership development. Plan to see the district with the best winning combination of gross membership gain and retention receive a distinctive award from our CHEA President Skip Henke in 2015. Look for CHEA Vice Presidents with net district membership gains to receive awards too. Finally, expect special recognition in 2015 for the Lodges in each membership category with the most effective membership programs.

Hints to win: Set your Lodge's gross membership goal at 10% and its membership lapsation at 2%. Maintain a membership team that includes the chairs of public relations, lodge activities, membership recruitment, orientation, and retention. Ask questions: Does the Lodge bill monthly and creatively? Routinely recognize proposers? Has every officer sponsored a member? How about the Lodge's image in the community? Does the Lodge have events that make it a destination that draws new members? Does the Lodge have a Second Step Program for new members?

Think about an Elks information booth at a community event. Have color-coded dues notices. Recruit and retain by telling the story of Elkdom: the Elks patriotism, the Elks charity, and the Elks significance in our American fabric.

## Pittsburg Elks Lodge No. 1474 uses Beacon Grant to help vets

The Pittsburg Elks Lodge No. 1474 presented a \$1,700 Elks National Foundation Beacon Grant to the "Veterans Employment Committee of Contra Costa County" at a Veterans Employment Committee meeting on May 7, 2014. A history of the Pittsburg Elks Lodge's role in helping soldiers during World War II and the Korean Conflict was read to the committee. Pittsburg's Camp Stoneman was the Port of Debarkation for soldiers leaving for the Pacific Campaign and Korea. The Lodge No. 1474 opened its doors to all military servicemen and women and their families. The Lodge was utilized for blood drives, selling War Bonds, making bandages, offering recreation, providing dinners and even had 50 cots available for families who had no lodging.

Today, the Lodge is assisting in the "Career Days" and "Job Fairs" that are put on by the Veterans Committee throughout Contra Costa County.

## **2014 CHEMPI theme child speaks at the convention**



Ethan Kempton was introduced to the assembled members of the California-Hawaii Elks Association (CHEA) Convention attendees on May 17, 2014. He bounded up the stairs to the speakers' platform accompanied by parents, Danny and Janelle Kempton, and his brothers, Taylor and Cameron. The California-Hawaii Elks Major Project, Inc. (CHEMPI) Occupational Therapist, Mavis Johnson, accompanied the family to the stage.

Ethan was born on June 16, 2006. His arrival was timed at two weeks prior to his due date because his mother had a history of huge babies. Labor was long and difficult and, when born, he suffered from oxygen deprivation due to the umbilical cord being tightly wrapped around his neck. In hindsight, it was a blessing that he was induced two weeks early, because he might have had even more severe brain damage had he gone to full term. Ethan spent a week in the neonatal intensive care unit before going home, and it was evident that he was having some undiagnosed medical issues. Over the next few months and years, it was apparent that he was having developmental issues with severely crossed eyes, inattentive behavior, lack of clear speech abilities, an overall lack of coordination, and little ability to crawl, sit, walk in a timely manner. Finally, in 2010, a neurologist was able to diagnose little 4-year old Ethan with a mild to moderate Cerebral Palsy. In addition to his CP, Ethan suffers from a myriad of physical, developmental, and psychological issues.

In 2011, Ethan was referred to CHEMPI, and Mavis Johnson came into his life just when Mom and Dad were scrambling for the means to afford private speech therapy to address his severe language and speech delays, let alone private Occupational Therapy. Mavis was challenged with providing therapy for a child who could essentially not communicate effectively and who could not do so many things that most kids take for granted, like sitting still, grasping a pencil, tie his shoes, button his pants, wear his clothing properly, write legibly, ride a bike/scooter/skateboard, jump on a trampoline, organize his thoughts properly, process proper sequences, etc.

With therapy techniques and other occupational therapy strategies, Mavis has worked wonders with Ethan. He has improved ten-fold since the Major Project came into his life. To be sure, his family has provided a lot of support with Mavis' direction. In addition, she was able to provide a plethora of community resources, advocates, social networks, and athome therapy ideas for Ethan. If she hadn't been a part of the Major Project, she would not have had access to these invaluable resources with which to share.

To the clear astonishment of those on stage at the Convention that Saturday morning, and to the delight of the assembled Elk members and guests in the audience, Ethan was joined by his mother and brothers to perform a four-person dance recital and demonstrated some pretty impressive dance moves. ## Honolulu Elks Lodge No. 616's donation of an AED saves a life

Last year, the Honolulu Elks Lodge No. 616 donated an automated external defibrillator (AED) to the Makua Alii Softball League (Editor's note: see the article on page 19 of the September/October 2013 California-Hawaii Elk Magazine).

AEDs can be found in airports and other places of public assembly. These devices, when properly placed upon a person's torso, will automatically detect any life-threatening cardiac arrhythmias of ventricular fibrillation and ventricular tachycardia, and is able to treat the condition through defibrillation. In layman's terms, it administers an electric shock to the heart muscle and causes the heartbeat to stabilize. We've all seen this type of therapy dramatized on television when the EMT places paddles on a person's chest, hollers "Clear" and the patient jumps from the jolt of electricity.

Well, on April 16th of this year, Dennis Kekona collapsed during a softball game. Kekona's teammates and opposing players rushed to his aid, initiated CPR and used the AED to get his pulse back. Honolulu paramedics confirmed that the use of the AED helped to save Kekona's life.

In other news, twenty-nine seventh grade students attending Washington Middle School participated in the Honolulu Elks Lodge Drug Awareness Essay Contest. A total of 29 essays and one poem were submitted. This year's theme was "Down with Drugs, Up with Awareness." Each student composed a one-page, hand-written essay on how the affects of drug abuse can hurt you and how to take steps against illegal drug use through education. Each student who participated was awarded a Participation Certificate, a \$5.00 McDonald's restaurant gift card and a Honolulu Elks Lodge No. 616 "purple sunglasses."



## Marysville Elks Lodge No. 783 donates \$2,000 to local non-profits

At a recent Elks National Foundation (ENF) Awards Dinner, the Marysville Elks Lodge No. 783 donated three cash awards, totaling \$2,000, to three local non-profit organizations.
