# San Fernando Elks Lodge No. 1539 awards \$40,000 in scholarships/grants

San Fernando Elks Lodge No. 1539 held a dinner and award ceremony to honor Luis Cueto, the 2010 recipient of the \$25,000 William. L. Frye Scholarship. Luis plans to attend the University of California at Riverside majoring in psychology.

Four other individuals also received scholarship awards or grants. A \$5,000 award was given to Andrew Jdaydani, who plans to attend Vassar and another \$5,000 award was given to Walter Garcia, who plans to attend Brown University. A \$2,500 grant was given to Kimberly Campos, who plans to attend Cornell University and another \$2,500 grant was given to Karen Carranza, who plans to attend UCLA.

Past recipients joined the celebration. During the award ceremony, they spoke about what they were doing in school and how the scholarships have allowed them to pursue a dream that may not have otherwise been possible.

Over the past five years, the Lodge has presented over \$400,000 in scholarships and grant money to deserving students. The Lodge expresses its sincere gratitude to its 1940's member, William L. Frye and his daughter Dorothy Hamil, for entrusting a legacy of over \$700,000 to the San Fernando Elks Lodge in the belief that Elks really do Care and Share.

# Rancho Cordova Elks Lodge No. 2484 helps disabled veteran

Recently, the Rancho Cordova Elks Lodge No. 2484 "Catch the Spirit" (CTS) Program answered a call for help from the Jackson Elks Lodge No. 2426 Veterans Committee and donated a motorized wheel chair to help out a Jackson Lodge "adopted" Veteran.

The adopted veteran, Army Staff Sergeant Charles Hanson was born on May 18, 1932 and enlisted in the Army in 1951. He was assigned to the 532nd Special Brigade, 2nd Engineers and served 6 years on active duty in the Army. Later, in 1975, he joined the California National Guard and served with them through 1988. Charles has been struggling with Parkinson's disease for the last several years and is now unable to walk from his home to his local market because he is unsteady and often loses his balance.

When the Jackson Lodge Veterans Committee learned that he had fallen several times in the last few months, they provided some assistance by driving him to the market and elsewhere – but it was on a somewhat irregular schedule. They wanted to be able to do more for Charles, but lacked the funds to do so.

The Jackson Lodge contacted PDDGER Bob Burns, Sr., the "Catch the Spirit" Project Chairman at the Rancho Cordova Elks Lodge. Bob was able to use CTS funds to purchase a motorized wheelchair that was donated to Charles. This will allow him enough freedom to complete the normal everyday tasks that all of us need to do.

The CTS Program has received three consecutive Grand Lodge ENF "Community Impact Grants" of \$10,000. This has been a significant factor in keeping the program going to help thousands of Veterans and military families every year. Donations to the Rancho Cordova "Catch the Spirit" program are tax exempt because it is a 501(c) 3 entity.

This unusual fund raising effort kicked off at the DDGER visitation as each Elk and guest present was challenged to donate \$5.00 to the ENF. The members and guests donated over \$715, making the evening a huge success. Each contributor received a special certificate and a pin to recognize their generosity.

### **Piggy Bank**

I hope that everyone had a wonderful holiday season! The Elk year continues on - seemingly at a very fast pace. Soon you will be nominating next year's Officer Corps and then electing them. And before you know it, we will be at the Association Convention in Fresno.

I would dearly love to hit that \$3,000,000 goal again – we CAN do it together! I would like to share some fund raising ideas that I discussed with the Exalted

Rulers and Leading Knights at the recent Mid-Term Conference. All of these ideas will increase our chance to achieve that goal.

I encourage all members to sign up to give a recurring monthly donation online. Currently, out of 88,941 members, we have 12 recurring donations. Please go on line to www.chea-elks.org for instructions on how to sign up. Even a \$5.00 per month donation would be a \$60.00 donation in the course of a year. If only a quarter of our members (22,235) signed up for \$5.00 a month, we would raise over \$1,000,000!

I encourage you to send for your 60 year anniversary pin. To date, pin sales have raised over \$35,000! It is a beautiful pin and a wonderful addition to your Century and 52 Club pins. These pins will only be available until March 31, 2011.

Ask your friends to use the Goodsearch.com program for internet searching and shopping on-line. Goodsearch.com is a search engine that allows you to select a charity (choose the California Hawaii Elks Major Project)—then for each search that you do, a penny is added to the Piggy Bank. You can also shop online through the Goodsearch.com search engine by clicking on the logo on their home page. It links you to another page that has LOTS of stores for online shopping. Each purchase will then cause a certain amount of your order to be donated to the Piggy Bank. Since April of 2008, we have raised \$443.41 this way. This year's total is \$172.18 (\$34.99 via searches and \$137.19 via shopping). I know that we can do better in both categories. Other charities are receiving thousands of dollars through Goodsearch.com. Spread the word. You need not be an Elk to use the Goodsearch.com search engine — just select the California-Hawaii Elks Major Project as the charity. It's extra money for the Piggy Bank that doesn't come out of your pocket. Please use this resource.

I encourage you to send in at least \$5 for the Christmas cards and \$5 for the labels you receive during the year. If each member sent in \$5 for the labels and \$5 for the Christmas cards, CHEMPI would receive almost \$890,000. That is close to one third of the amount we are trying to raise this year! Just fill in the "Other" line on the card with the \$5 and send in your money.

As you can see, just a small donation from all members puts a lot of money in our Piggy Bank for next year's ER March. I encourage you to continue donating to receive your Century and 52 Club pins and certificates — I certainly don't want to discourage any large donations!

Remember it takes \$4,400,000 to run our program for one year. Every dollar we donate reduces the need to make withdrawals from the investment account — leaving the account intact for future use. I certainly want to see our program continue for another 60 years — How about you?

The Carmichael Elks Lodge No. 2103 donated two swamp coolers to "Loaves and Fishes." These coolers will be used in their dining room. "Loaves and Fishes" feeds a large number of homeless men, women and children in Sacramento, CA.

### **Purple Piggy Bank History**

#### January 23-24, 1954

Past Grand Exalted Ruler Faye Lewis reported on the "Penny-A-Day" plan which he instituted in the lodges throughout the state; that it was just a trial plan and it turned out very well; that up to the present time over \$12,000.00 has been received and more coming in each day; that a number of the lodges did not respond, but the lodges that did, received a great benefit because of the enthusiasm with which it was received, will help the work of the lodge in many ways.

Committee moved that a sub-committee be appointed to determine the cost of a small bank for mailing to each Elk in the State and the means of distribution of same.

#### February 22, 1954

Approval given to purchase 110,000 piggy banks from the Wes-KoProducts of Los Angeles, a bank known as the "no. S-50 Snooty Jr.", a 3 ½" x 5 ½" bank with a tipping hat and a removable plug underneath for removing coins. The bank to be in purple and white plastic with the lettering on one side "California Elks Major Project" and the other side "A coin a day-they walk and play." Large banks were also ordered.

#### April 10, 1954

Over 75% of the banks have been mailed to the lodges.

#### May 15, 1954

Committee decided not to place the piggy banks in public places.

#### August 21, 1954

Committee given a copy of a letter from President Keller asking lodges to hold a "Piggy Bank Night" during the month of September 1954 of members to deposit the contents of their banks and asking each lodge to present a check at the State Convention for the total.

1953-54 Piggy Bank Contributions at convention was \$13,027.73.

1954-55 Piggy Bank Contributions at convention was \$76,851.74.

2009-2010 Piggy Bank Contributions at convention was \$3,062,368.50.

#### **Elks National Foundation**

The "Vice Presidents' ENF March" took place on Saturday, November 6, 2010 at the Mid-Term Conference in Santa Clara. It was a very successful event. The Vice Presidents reported on the totals that had been raised and the per-capita of their respective Districts as of October 24th. Many of these reports included very interesting information about the donors and their fund raising programs. The result of all of their hard work is reported here.

Much of the work is done by the ENF District and District Chairmen. It is these chairpersons who provide the leadership necessary for successful fund raising programs in the various Districts and Lodges. Their work is appreciated.

The District winners for highest donations were: 1<sup>st</sup> - North Central District (\$34,204.70), 2<sup>nd</sup> - West Central Coast District (\$33,798.76), 3<sup>rd</sup> - Orange Coast District (\$29,831.00).

The District winners for the highest per-capita donations (\$4.50 is the goal) were: 1<sup>st</sup> – South Central Coast District (\$6.80), 2<sup>nd</sup> – Metropolitan District (\$6.68), 3<sup>rd</sup> – North Central District (\$6.25).

The Lodge winners for the highest donations (these were not announced at the "ENF March") were: 1<sup>st</sup> – Carmichael Elks Lodge No. 2103 (\$14,232.53), 2<sup>nd</sup> – Honolulu Elks Lodge No. 616 (\$11,587.20), 3<sup>rd</sup> – San Jose Elks Lodge No. 522 (\$9,761.50).

The Lodge per-capita winners (also not announced at the "ENF March") were: 1<sup>st</sup> – Santa Monica Elks Lodge No. 906 (\$19.21), 2<sup>nd</sup> – Glendale Elks Lodge No. 1289 (\$17.11), 3<sup>rd</sup> – Calpine Elks Lodge No. 2432 (\$16.46).

The total donations for CHEA up through October 24<sup>th</sup> (not counting bequests) were \$341,730.24 with a per-capita of \$3.84. In addition, \$27,216.07 was collected at the Conference, for a grand total of \$368,946.31, for a per-capita of \$4.13. Last year at the same time, our total was \$362,314.00, for a per-capita of \$3.96.

Four months of the 2010-2011 fraternal year remain. There is still time for Lodges to apply for the Gratitude Grant – which provides for up to \$1,000.00 for community programs. Fund raising efforts must continue until March 31, 2011. Awards to the year's per-capita winners at both the District and Lodge levels will be made then. We must increase our efforts. Everyone at every level must become involved. Let's promote the Elks National Foundation enthusiastically!


#### Thanks for a successful Mid-Term Conference

OFFICER SELECTION, DUTIES, AND RESPONSIBILITIES

As the third quarter of the year continues to unfold before us, we see it as a most challenging period. As our priorities and level of needs change, so must our commitment to positive members growth.

During the first six months of the current fraternal year that started on April 1, 2010, the Association had a net gain of 2.02%. Our membership goal is a

10% gain. We must continue this momentum with enthusiasm and dedication. We cannot sit on our laurels - not just yet.

The final three months are the most important of the fraternal year. These are the months when we should be working stronger than ever to attain the goal of a 10% gain or at least a PLUS ONE. We should set an example to the next corps of officers. Give them a head start by keeping our Lodge active and enthusiastic - by recruiting new members and retaining all of our current members.

The most important of the three months is February. The most important decision made each year is the election of incoming Lodge officer corps and making plans for your Lodge's new fraternal year.

Leadership and planning go together. We need to simply and systematically set aside time to dream about the future, elect our next leaders, envision the possibilities, set goals, outline strategies, and establish time lines. To become an effective Leadership Team, we must be aware of the duties and responsibilities of being team leaders.

My Brothers and Sisters, a Lodge is no stronger than the officers guiding it. Each officer, trustee, house committee member, committee chair or member, is a leader of the Lodge and is looked upon for the qualities of leadership. Any consideration to the election or appointment to an officer position should be based on that individual's attitude, personality, knowledge, and ability.

It is also important for the prospective officer (and spouse) to understand what is expected of them in terms of their time commitments, their financial strength and the motivation that will be needed for them to successfully fulfill the office that he/she will hold.

Too many times, officers do not complete their term of office or continue through the chairs simply because they did not understand what was expected of them or could not handle the pressure. This breaks the chain of leadership succession in the officer corps. As a result, we often have to keep recycling Past Exalted Rulers to fill vacancies - and we, as PERs, are not getting any younger.

Prospective officers, trustees, house committee, and committee chairs, please take time and consider the following:

Time Required: Do you have the time for Lodge meetings, and Lodge events? Can you take time away from your family and will they (specially your spouse) support you in your Lodge work? The time you spend at the Lodge is up to you. Lodge meetings are once a week or twice a month and normally last an hour or two. Officer and committee meetings are once a month and last about an hour.

Financial Consideration: Can you afford to become an officer without creating a financial burden upon yourself and family? The expected expenses are for a Lodge uniform and a tuxedo. The tuxedo is worn at every Initiation. You can also wear it at any other formal event. This is money well spent. It is recommended that you attend the VP and DD visits, and the conventions. The Exalted Ruler has to attend State and Grand Lodge Conventions. The E.R., Leading Knight, Chairman of the Trustees, and Secretary, are expected to attend DD Clinics and Mid-Term Conference.

Motivation: A prospective officer might be asked: Why are you considering becoming an officer? What do you believe you can offer your Lodge as an officer? Are you willing to continue through the chairs if you become an officer? Can you handle the pressure? Think about it.

You have to be strong, maintain a positive attitude, and be enthusiastic about the job.

Responsibility: It is the duty and responsibility of every officer, trustee, and house committee member to assist the Exalted Ruler in conducting the business of the Lodge. The success of the lodge and a gain in Membership depends on all of the above. Therefore, it is important to prepare and familiarize yourselves by learning the following: the charitable aspects of Elkdom, the laws governing our Order, the day-to-day operations of the Club and Lodge management, protocol, the Exalted Rulers, Lodge Officers and Committee Members Manual, and, most importantly, the 5 booklet-set of Leadership Training Manuals. A strong and knowledgeable Leadership Team will most certainly add a Plus One membership to "Elks-America's Pot of Gold."

### California-Hawaii Elks Major Project, Inc. Board of Trustees

Having recently had the opportunity to attend the Professional Institute at Bass Lake as Liaison of the Continuing Education Committee, it was my pleasure to meet with the Professional Staff of the California-Hawaii Elks Major Project, Inc.

The CHEMPI Continuing Education Committee consists of the Chairperson (a Regional Manager) and four members of the Professional Staff. A Trustee is appointed as liaison by the Chairman of the CHEMPI Board of Trustees. The Committee is responsible to the

Board of Trustees to whom periodic reports will be made.

The function of the Committee is to oversee and assist in the planning of Continuing Education Programs and recertification for the CHEMPI Professional Staff. A series of multi-day workshops, presentations, interactive exchanges, and innovative therapy role plays were conducted in October during the annual Professional Education Conference at Bass Lake. Outstanding guest speakers and acclaimed doctors presented new therapeutic techniques and concepts for incorporation into their professional best practices. The continuous adoption of new techniques and educational refreshment enhances their delivery of the most effective therapies to the children. In addition to this single annual conclave, additional meetings may be convened by the Continuing Education Committee Chairperson at the request of any member. As such, there was discussion regarding the cost-effective use of periodic internet-based meetings on a tri-mester basis to increase therapist interaction and case knowledge sharing.

Other duties and responsibilities of the Continuing Education Committee include being knowledgeable of the continuing education requirements of professional licensure, providing employees an opportunity to comply, and making recommendations for the implementation of educational programs.

The CHEMPI therapists and Preschool Vision Screeners are dispersed throughout California and Hawaii. Each therapist provides services to case loads of as many as 25 children. #### **Drug Awareness**

It's a lot more difficult being a kid today than when we were kids. It is even harder when alcohol and drugs get in the way. Research tells us that far too many kids are using drugs. One in four high school seniors say that they have taken a prescription drug without consulting a doctor, according to the U.S. Center for Disease Control and Prevention. According to the National Institute on Drug Abuse, data shows that more 10th graders smoke marijuana than cigarettes and 25 percent of high school seniors report binge drinking

The Elks Drug Awareness Program (DAP), an arm of The Benevolent and Protective Order of Elks, has been giving generous support to assist community leaders and educators in an effort to best address the emerging threats facing America's young people.

The 2009-2010 Grand Lodge DAP budgeted \$193,000 to print pamphlets, brochures, CDs and DVDs that would then be provided at no charge for distribution throughout this magnificent nation. In addition, \$100,000 was allocated to cover the shipping costs to distribute these materials to the Lodges that requested them. To further enhance this Program, \$36,420 was given by Grand Lodge as a grant to CHEA's Drug Awareness Program.

Elk volunteers, working with schools and community leaders, continue to chip away at one of our nation's most prevailing and pervasive drug problems: prescription drug abuse. The Elks Drug Awareness Program is one of the highest funded programs within the Elks budget and is the largest volunteer drug awareness program in the United States.

A Lodge with an effective drug awareness program does not just pass out an enormous amount of free literature. The DAP Chairman is also in contact with local law enforcement and works closely with school counselors, faculty members and community leaders. The Chairman holds drug awareness events at the Lodge and at schools in order to introduce some of the Grand Lodge DAP programs such as the Essay and Poster Contests and to hold competitive events such as a bicycle safety rodeo.

This year we are fortunate to have been able to obtain another grant for an "Elroy the Elk" costume. We will now have a total of 3 costumes in California. Sadly no "Elroy the Elk" costume is presently available to Lodges in the Southern portion of the state - this is due primarily to the lack of effort in applying for the grant. Many factors are considered in approving the grant such as: are there other costumes nearby and how will the costume be used?

Thus far, this year has been successful due to the labors of the DAP District Chairmen as well as the front line Lodge Chairmen, who have given their utmost in time, talent and dedication in the promotion of the Drug Awareness Program.

# Santa Maria Elks Lodge No. 1538 honors local law enforcement

### **Scholarship**

### WHAT'S ALL THE FUSS ABOUT ACCREDITATION?

Greetings to all Elks! Especially to those who are involved with our great Scholarship Programs. This is the time of the year when Elks Lodges throughout America are deeply involved in the Most Valuable Student Scholarship Program and various other scholarship programs. I am sure that by now you have come across the phrase that your MVS applicant must

be enrolling in an "Accredited Institution." What does this exactly mean?

There are six regional accrediting agencies that are recognized by the U.S. Department of Education and the Council for Higher Education Accreditation (CHEA). This is not the CHEA we are all so familiar with.

These six regional accrediting agencies are: (1) the Middle States Commission on Higher Education, (2) the New England Association of Schools and Colleges, (3) the North Central Association Commission, (4) the Northwest Commission on Colleges and Universities, (5) the Southern Association of Colleges and Schools, and (6) the Western Association of Schools and Colleges. In addition, there are some other accrediting agencies that evaluate Faith-Related Institutes and Career-Related schools.

Why do we have all of this accrediting activity in our schools of higher education? Simply put, these agencies accredit entire institutions. All are equally authoritative and recognize each other as such. This means that credits or degrees earned from a school accredited by one agency will be recognized by a school accredited by another agency. Also, the accreditation process acts as a quality check on all of the programs that are being offered by the participating institutions.

One of the main purposes for all of this is to protect the students and future employers from diploma or degree mills. Some degree mills blatantly offer to sell a degree and perhaps a transcript from a legitimate school. Others can be easily recognized by promising that an applicant can receive a degree in a very short period of time, sometimes as short as five days. Another type of degree mill will purport to look at an applicant's life experience and award a degree based solely on a description of this experience. An advertisement that claims a student can "earn" a degree in much less time than it would take at a legitimate institution is likely evidence that the school is a degree mill. Obviously, such diploma or degree mills are not "Accredited Institutions."

Therefore, it is important that the Lodge Scholarship Chairs check on the "standing" of the various schools our scholarship recipients are enrolling in. As mentioned previously, it protects the student, the future employer and the Benevolent and Protective Order of Elks.

### Lake Elsinore Elks Lodge No. 2591 rises from the ashes

Almost three years after the disastrous fire which destroyed the lodge on November 7, 2007, the newly rebuilt Lake Elsinore/Wildomar Elks Lodge No. 2591 opened its doors on September 2, 2010. A formal Dedication and Grand Opening Dinner was held on Saturday, October 2, 2010, when Grand Lodge Officers led by Manny Gomez, PER, PDDGER, followed Grand Lodge Ritual and formally dedicated the new Lodge building. Approximately 300 people from the Lodge and the Southeast District attended the event.

The Lodge hosted its annual seniors' Free Thanksgiving Dinner at the new Lodge on Wednesday, November 23rd. #### **CHEA Board of Trustees**

This article will acquaint the membership with the organization and purpose of the California-Hawaii Elks Association (CHEA) and the responsibilities of the Board of Trustees (BOT).

The purpose of CHEA is spelled out in the Preamble to our Constitution, which is too lengthy to print here. A quick summary of the points in the Preamble would include encouraging patriotism, charity, good fellowship and promoting the programs of the Grand Lodge.

The organization of CHEA is based on the membership of all Lodges in the States of California and Hawaii. Associate membership is available to Lodges in the Philippines and Guam. The Association is required to have annual meetings and mid-term conferences as determined by the Trustees.

CHEA has elected Officers as follows: President, First Vice-President, Secretary, Treasurer, and a VP from each District and a Board of Trustees. Officers appointed by the President are Sergeant-at-Arms, Chaplain, Organist and Tiler. The Trustees are empowered to create and fill the position of the Executive Director.

The CHEA Trustees have general charge of the property of the Association and the direction of its affairs. The Board is composed of nine Trustees, elected for three year terms; three Trustees being elected each year.

Trustees represent two Districts (in one case, three Districts), and the office alternates between the Districts involved.

Trustees have duties and powers that are similar to Lodge Trustees. Some of the duties are: control of the finances, adopt the budget, submit budget for approval, report at conventions, set the per-capita assessments, arrange for audit of the finances, oversee meetings of CHEA, and remove Officers for good cause.

The Board is structured by a Chairman and Vice Chairman. The Board has members on various sub-committees as follows: Budget, Insurance and Safety, Salaries and Benefits, and Investments.

The Board receives valuable input from the Meetings Committee regarding potential host Lodges for the Annual Conventions and Mid-Term Conferences.

The CHEA Trustees also receive outstanding assistance and guidance from the Executive Director, Past Association President Tim Martin and his Fresno office staff. The budget proposals received from the Director are extremely accurate, professional and well thought out.

This is my third year as a CHEA Trustee, and it has been a very rewarding experience. I've been privileged to serve with some outstanding Elks and I'm sure that next year's new members will continue the tradition.
