



The Beacon Grant needs to be used in a visible and meaningful way to benefit the community, promote the Lodge's image in the community, attract new members and show the good things that Elks do. The Richmond Elks Lodge successfully applied for and was awarded a \$2,000.00 Beacon Grant.

The Lodge will use the Grant for two projects at St. Paul's School in San Pablo. The first project will be to complete the infield of the school's baseball field. The Lodge is hoping that St. Paul's School will name the baseball field "Elks Field." For the second project, Lodge members will build raised compost beds for a demonstration garden and other related science projects.

Hemet Elks Lodge No. 1740's Auxiliary delivered supplies for our troops

The Hemet Elks Lodge No. 1740's Auxiliary delivered 12 boxes of supplies for soldiers to the Hemet Bank of America. The supplies were collected by the Auxiliary during the month of December at the Lodge and also at the Lodge's annual Christmas party. Among the items donated were: 61 knitted hats, 200 neck coolers, 58 pairs of socks, 41 hand warmers, 49 paper back books, 9 sewing kits, 40 game books, 51 juice boxes, 37 packets of hot chocolate, 38 decks of cards, 45 packages of gum/candy, and assorted personal items such as toothpaste, deodorant, talcum powder, razors, etc.

According to Kevin Santana, the Bank of America's contact for their program, "Bank of America Supports Our Troops," the supplies delivered by the Elks will be sent overseas to the troops in January. The bank has a list of supplies that the troops need and sends them out on a quarterly basis. "We will sort the supplies brought in by the Elks into shoe boxes to be delivered to individual members of the military," said Santana, adding, "We like to get the donations already packed in shoe boxes, but we're happy to re-package them this time." He went on to say, "This program has been advertised by word of mouth, and we hope that more groups and individuals will bring these donations into Bank of America."

Sean was accompanied by his parents, Bob and Sandy, and his 11 year old brother Daniel. Rod Propst, a past Scoutmaster and Troop committee Chairman, sponsored Sean because of his love of God and of the American Flag, and for demonstrating a lifestyle that is free of drugs and alcohol.

Sean received a framed certificate and tickets to the Lodge's Sunday brunch from ER Rock. Other Lodge members presented him with gift certificates for money and dinners at various restaurants. Before the presentations, the family enjoyed a complimentary dinner. Sean introduced his parents and his brother, and then described his hobbies and his accomplishments at Troy High School in Fullerton. Sean earned his Eagle Scout badge at the age of 15 and is a member of the Scout's Order of the Arrow.

Orange Elks Lodge No. 1475 helps a local youth

Orange Elks Lodge No. 1475 member John Hollaway brought the Lodge's attention to a family friend and local young man, Zack Collie. He is a typical 17 year old living in Southern California. He enjoys hanging with his friends, playing on-line video games, dirt-biking in the desert, camping at the Colorado River, watching movies, texting his friends, going to the beach, taking boxing lessons and was on the Yorba Linda High School wrestling team.

On Memorial Day, 2010, all that changed. Zack sustained a life-changing injury while bodysurfing at Newport Beach, CA. He broke his neck at the 4th vertebrae and damaged his spinal cord. He was immediately paralyzed, fully conscious, and floating face down in the surf. Fortunately for Zack, his friend was close, turned him over and got him to the beach, thereby saving his life. Zack was rushed to Hoag Hospital and then transferred to CHOC in Orange, CA. After a six hour operation he remained at CHOC for two weeks. From there, he was transported to the Casa Colina Inpatient Rehabilitation facility in Pomona, where he remained for six weeks. He was taught life-skills to learn how to function with his disability. He had some movement in his forearms and was paralyzed from the chest down.

After Zack was released from Casa Colina, he chose to enter an outpatient physical therapy program at Project Walk in Carlsbad, CA, where he visits twice a week for ongoing therapy. He chose Project Walk because it is an intensive exercise-based recovery program designed to stimulate the nervous system. This is not a six month, or one or two year program. It is an ongoing program that is dedicated to push you as hard as possible so that you can recover as much as possible - however long it takes. This is the program that their clients have chosen who have made the most recovery. At a recent therapy session, his trainer pulled Zack to a standing position, placed in a walker in front of him and Zack was able to lift his foot and swing it forward.

The Orange Elks Lodge donated \$500 to Zack for his therapy sessions.

Fremont Elks Lodge No. 2121 donates to Boy's and Girl's State

What do Rush Limbaugh, Michael Jordan, George Pataki, President Bill Clinton, Vice President Dick Cheney and Tom Brokaw have in common? They all attended the American Legion's Boy's State Program. What is the Boy's and Girl's State Program, you might ask? In 1935, Hays Kennedy and Harold Card became concerned about the youth of America attending fascist training camps. They felt that it was important to have a counter-movement to stress the importance and value of our democratic form of government. The strength of our nation lies not only in the size of our armed forces, but also in the character, loyalty and intelligence of our citizens. American citizens who understand our government and who recognize their duties and obligations to our country are the foundation and backbone of this country.

The Boy's State and Girl's State Program is offered to high school juniors who are recommended to local American Legion Posts by their schools. This week long program, offered separately to boys and girls, teaches the students how city, county and state governments are organized and how they function. They learn through participation in mock executive, judicial and legislative bodies that emulate the real thing. It is a "learning by doing" program. These students carry the skills and knowledge acquired through this experience back to their schools and communities. Many employers, service academies and university admissions boards believe that participation in the Boy's State or Girl's State Program is another indicator of a student's strong leadership and character traits.

The Fremont Elks Lodge has donated money to their local American Legion Boy's State and Girl's State Programs each year for many years. The Lodge's contribution helps the American Legion Post fully sponsor each student's attendance to the Program, thereby making a positive difference in their lives. Local graduates of the Boy's State and Girl's State Programs have gone on, following their high school graduation, to attend the West Point and Air Force Academies, the Merchant Marines Academy, Princeton University, Harvard University and many more fine colleges and universities. Others have also worked as aides to California Legislators in Sacramento. The Lodge is proud to continue sponsoring this program which has benefitted the lives of so many of our local youth.

Westchester Elks Lodge No. 2050 raises money for LAX USO center

The Westchester Elks Lodge No. 2050 held their annual Charity Ball in December which raised over \$1,100 for the Bob Hope Hollywood USO Center at the Los Angeles airport. The Lodge presented a check to the Center's Director of Operations, Barbara Musella. They also donated multiple cases of water and soda. The Center is open 24 hours a day and is one of the finest state-of-the-art USO Centers in the world. It provides a comfortable and welcoming "safe haven" for our servicemen and women and their families.

The 4,000 square foot Center offers its famed "Hollywood Canteen" snack bar, a big-screen TV lounge with a library of thousands of Hollywood's current and classic films, The General Jimmy Doolittle Lounge and free lending library, a full-service Internet Computer Center, a Disney inspired family room, a nap room with leather recliners where troops can catch a few winks between flights or remain overnight, a secure luggage storage room, men's and women's restrooms and showers, an outdoor patio and barbeque and more.

All services are provided without charge to military personnel and their families. Additional services include the free use of cell phones to call home; a team of volunteers to assist with onward transportation services; use of nationwide fax services; short-term temporary parking for brief visits, passenger pick-up and delivery; free DVDs and music CDs from Operation DVD, as well as discounted hotel reservations.

Membership

My fellow Elk members, the membership performance has been on a roller coaster - up and down and on its way to positive results. It is evident that your continued support, dedication, hard work and enthusiasm have paid off. I congratulate you and express my appreciation to all of the District Chairs who have so diligently sent in their reports.

The Chicago Lodge Management System version 2 ("CLMS2") report as of January 15, 2012, shows that

the California Hawaii Elks Association has a net membership gain of 3.23%. Our goal is to attain a 10% increase in membership. Speaking of percentages, the percentage gain by districts are as follows: South Central Coast 7.76%, Hawaii 6.45%, San Gabriel Valley 6.32%, West Central Coast 4.60%, Orange 4.26%, West Central 4.01%, South 3.98%, Bay 3.21%, Northeast 3.00%, Metropolitan 2.96%, North 2.90%, North Central 2.87%, East Central 2.50%, Inland 2.36%, South Coast 1.64%, Northwest 0.94%, Central 0.76%, South Central -0.24% and the Southeast District -0.73%.

The CLMS2 report indicates that the Association has experienced a membership gain of 6,726 and a loss of 3,910 for a net gain of 2,816 and the ending membership of 90,024. The results are very promising. However, the CLMS2 Lapsation numbers, show a total delinquency of 7,553 for a percentage of 8.39%. The Lapsation goal is 2% or less.

It is important for us to continue our hard work and, with determination, try to keep those delinquent members from being dropped from our membership rolls. I encourage and ask each Elk, and every family member, to take part in the activities of your individual Lodges and to lend a hand whenever possible. Remember, we are a family oriented Order and, by promoting and encouraging family participation, we will meet the challenge and end up with a plus membership gain.

Not only must we try to save our lapsed members, but we must also try to recruit new members. One great way is to take advantage of the new Membership Inquiry Program. Membership inquiries are now being accepted online through the elks.org website! This means that non-members now have a quick and easy way to express their interest in joining the Order.

Here's how the system works:

- 1. Members of the public, many of whom may not know a member of the Order, may express their interest in membership by submitting an online inquiry form: http://www.elks.org/who/default.cfm.
- 2. An email is sent to the secretary of the Lodge with jurisdiction over the zip code included in the inquiry. The Lodge Secretary will also see an online notification when they sign on to the CLMS2 websites.
- 3. The Secretary, or another Lodge member, will contact the potential candidate within seven days via email, telephone, or U.S. mail and let them know the best way to introduce themselves to a member or the Lodge. Hopefully, this will result in an invitation for membership. Please note that our membership procedures have not changed: Candidates must still be invited to join.
- 4. Once contact has been established with the potential candidate, the Secretary will visit the CLMS2 website to mark the transaction as processed. This step is very important, since Grand Lodge staffers and/or CHEA Membership chairs will be following up with all secretaries regarding any overdue membership inquiries in their jurisdiction.

At the upcoming CHEA Convention in San Diego, there will be a workshop on Membership Recruitment and Retention. I encourage you to attend and participate.

That's it! Hopefully this simple program will make it easier for more individuals to join the Order and discover first hand that "Elks Care, Elks Share" and that "Elks Live Aloha."

Lapsation

The first nine months are in the books. The Lapsation rate for all 19 Districts is 19%. There are three Districts with good Lapsation percentages for the first 7 months: Central District – 4%, Northeast – 5%, and West Central Coast – 5%.

On the other end of the spectrum, there are five Districts at 9% and others at 11%. The remaining Districts fall in the range of 6% to 8%.

We still have an issue with some Districts retaining delinquent members for as long as 18 months. There are 58 members that should have been dropped after one year. I will contact the District Lapsation Chairmen and see what I can do to help them with this problem. It is now time to address this issue and try to get it resolved.

I continue to feel that the Lodges and Chairmen are doing a good job this year. My goal is for all Lodges to be at 7% at the end of 9 months, and I believe that you are showing that this can be done. Please let them all know how much their help, and yours, is appreciated.

Conflicting School Views

To paraphrase Yul Brenner in "The King and I", "Schools are puzzlement." On the one hand, we have researchers and writers lamenting the schools' cruelty and ineffectiveness, even preparing the institutions' obituary. On the other side, many Americans continue to view schools as a panacea capable of resolving most, if not all, of society's problems. A puzzlement indeed.

Nor is this puzzlement brought much closer to a resolution by educational research. Some of this research has pointed out the limitations of schools; other studies indicate that schools make an important difference in the lives of children. They have found out that, as peoples' formal education increases, they read more newspapers, books and magazines. Consequently, there is an increased awareness of domestic issues, foreign events, and popular culture. This research suggests that schools do make a difference.

Other educators stress the importance of the early formative years and suggest that the effectiveness of schools could be dramatically increased if schooling began at an earlier age.

Perhaps part of the answer to this conflicting point of view was provided by the noted educational historian Lawrence Cremin. Cremin suggests that schools be relieved of some of the heavy educational load placed on them. He believed that schools should no longer be viewed as the sole mechanism through which education is dispensed. And he points out that the church, the family, and the ethnic group all contribute to a child's education. Schools alone do not hold a monopoly on learning.

Cremin's argument points out the paradox of America's schools. Because so much is expected of them, schools are destined to fall short of success. But the very fact that so much is expected of them also demonstrates the deep confidence people have in public education in general and schools in particular. The unrealistic expectations held regarding schools are in themselves an expression of America's deep, abiding faith in the institution. Perhaps this is one reason why schools have withstood a withering rain of criticism and why many polls reveal that parents remain overwhelmingly satisfied with schools.

As you can now see, the purpose of schools is in the eye of the beholder. And there are many beholders. People expect schools to do everything from solving unemployment to developing humane and loving adults. Although schools fall short of meeting the numerous and often contradictory goals expected of them, they do remain a central and vital institution within our society.
