A portion of the funds raised from the event was donated to the Wounded Warrior Project, which was represented at the event by the "Rebuilding Warriors" and "Warrior Built." # San Francisco Elks Lodge No. 3 raises money for community charities

May - \$475 was raised for the Boston Children's Hospital and One Fund Boston to assist the city of Boston in the wake of the Boston Marathon bombing.

In other news, on Wednesday, October 23, the members of the lodge turned out to watch baseball, play pool, enjoy good German food and dance to polka music. The fundraiser benefited the ENF Veterans' Fund by raising just over \$1,500 in donations.

#### **Elks National Foundation**

Members, thank you for your generosity to the Elks National Foundation (ENF). Your donations continue to support our national programs, which keep us in the forefront as an organization that is known for its "Charity and Patriotism."

Today, the ENF not only supports our many youth and veteran programs, but also gives "cold cash" back to our local lodges to fund their charitable giving

programs, thereby assisting our citizens who are in need of a "warm heart." This Community Investment Program offers different Grants to local lodges that qualify and apply. The Grant money is free, interest free, never has to be repaid, but just must be accounted for.

There seems to be some confusion about the grant program. Only 25% of the available grants have been awarded to CHEA Lodges. I suggest that each lodge appoint a Grant Coordinator to work with their Charity Committee. Together they can select projects to support. The coordinator will know when to apply, can oversee the grant application and write the final report, which is due at the conclusion of the activity.

There are three grants available that every lodge should be able to qualify for. The Gratitude Grant is awarded to lodges that meet the Grand Exalted Ruler's membership per-capita goal and must be used for local charitable activities. The Beacon Grant is awarded to lodges for a new project in the lodge or to support a continuing project from a previous year. It must be ongoing, led by Elks, strictly charitable to help those in need, and must be an activity, not a donation. Finally, Promise Grants encourage Elks to devote time to America's youth. This grant is available to the first 500 lodges that apply and host an Elks led youth event. Receiving these three grants will give your lodge an extra \$6,000 to use for charity. Very few applications are turned down and most refusals are due to insufficient information on the application. Let the Grant Coordinator do it.

There were five \$10,000 Impact Grants awarded to lodges in our Association in this past year. These grants are awarded on a competitive basis with all Elk Lodges nationally. They offer lodges a chance to serve the community in a significant way. Applying for and being awarded an Impact Grant is challenging. Take the easy money first then let the grant coordinator organize a committee to put together a plan of action to compete for an Impact Grant.

It is challenging and sometimes difficult to ask members to donate to the ENF. With everything else we do in life, from time to time we should try to do just a little bit more. You may remember that I have promoted the ENF Fidelity Club, which allows donors to contribute with an automatic, scheduled gift. This is an easy way to give \$5.00 per month or more. The amounts can be charged to your credit card or be taken as a direct debit from your bank account. Your Lodge Secretary or ENF Chairman can assist you with a confidential mail in form.

The Elks National Foundations continues to do more. With your continued help, we, as Elks, will continue to be recognized for our "Charity and Patriotism." Again—I Thank You!

I discussed the fact that the lodges, which have formed teams this year, and have stayed the course, have been successfully increasing their membership. One District implemented the team concept in almost all of their lodges and increased its membership by 6.6% or 346 new members.

We may not have met our goals in 2013, but so far in 2014, we are making progress. We still continue to lose on average 2 to 3% of our members each year. It will take time to turn these numbers around, but it is still possible, by working as a team, for us to accomplish our goals. Membership continues to be the lifeblood of our organization. Letting the community know what we do is of prime importance. The more we work with the various entities throughout the community, the more our membership will grow. This can be accomplished by using the various Grants that are available from the Elks National Foundation. Thousands of dollars are available to assist us in focusing on our community and to help those in need.

As our new year approaches and as we form our new committees, it would be a great time to put together a Grant committee in your lodge. In closing, we are doing a good job, but we need to make a strong finish at the end of the Elk year. Think about whom you can recruit as a worthy member or, better yet, call an Elk friend that has not paid his/her dues and get them back before they get dropped. Help make your Lodge a+1 Lodge.



#### Why wasn't my photograph included?

A note from the Editor

Sometimes a photograph isn't included because there isn't room. Generally, there are other reasons not to include a photo. The biggest factor is the quality of the picture. Pictures taken with a cell phone are often of poor quality – perhaps good enough to email to someone or post on a web site, but often these are not good enough to be considered for publication. Please refer to my editorial guidelines at http://www.cheaelks.org (click on "CHEA Magazine" at the top). Please note that I prefer to have electronic photographs, not hard copy prints. Also, do not embed your photographs inside your word document, but send them as a separate attachment to the email.

Sometimes the photo is just too blurry, is poorly composed (subjects are too far away), the lighting is poor (too dark, too light), or the camera has put a date stamp in the picture. Also, it is important that the photo illustrates the story that your article is describing.

Photos taken with a digital camera (or cell phone) need to have the settings adjusted so that the photo is of the highest quality. The camera should have at least a 4 megapixel capacity (the more, the better). Check your camera settings—look for a setting that will give the greatest number of pixels (must be greater than 1,500 x 900 pixels, or dots per inch, but the more, the better). 
#### Lancaster Elks Lodge No. 1625 served veterans and children
