







President's Message

Temecula Valley Elks Lodge No. 2801 visits hospitalized WWII veterans

The Temecula Valley Elks Veterans Committee regularly visits their sponsored 1-S and 1-SE wards at the Jerry Pettis Memorial Veterans Hospital in Loma Linda, California. At their March 10, 2012 visit they were honored to meet and visit with three WWII Veterans. Two of them were also Prisoners of War (POW) in their respective campaigns.

The Temecula Elks Veterans Committee is made up of California Army National Guard First Sergeant, Steve Nunez, who is the Committee Chairman. Co-chairs are Laurie Gonzalez, Paul Gonzalez, PER, and Steve Zeeb, USAF Master Sergeant (Retired). The Gonzalez's two granddaughters, Emily and Erin Nunez, are also part of the Committee, and are often heard saying "Thank you for your service" to the bed and wheelchair bound patients.

The Elks had the honor of meeting 92 year old Byron Cunningham, an Air Force B17 Bomber Captain who piloted a number of missions over Germany, where he was shot down and captured as a POW. Byron recounts that his bombers were often guarded by the famous Tuskegee Airmen / Red Tail fighter escorts and that the infamous German Luftwaffe often flew away and were intimidated by these heroic American fighters.

In other news, the Lodge continues participating in the Dictionary Project, delivering dictionaries to 3rd grade elementary school students. At the beginning of the year, they had delivered dictionaries to seven elementary schools in the Temecula Valley School District: Abbe Reinke Elementary, Helen Hunt Jackson Elementary, Nicholas Valley Elementary, Pauba Valley Elementary, Rancho Elementary, Temecula Elementary and Ysabel Barnett Elementary. A total of 948 dictionaries have been presented to date. In February, the Elks planned to continue the project to include at least five additional elementary schools - which will double the number of schools served over the previous year.

Willows Elks Lodge No. 1786 holds annual Pinewood Derby

Cub Scout Pack 68, sponsored by the Willows Lodge No. 1786, held its annual Pinewood Derby on Saturday, January, 28, 2012. The event was attended by 100 family members and Cub Scouts. The Fullerton Elks Lodge No. 1993 has a monthly "Special Child Program" where they bring a "Special Child" to the Lodge with his/her family members. During the visit, the family is treated to a dinner and the child receives gifts from the Lodge.

February's "Special Child" was Zachary Cannon. Zachary visited the Lodge with his mother, Tricia Cannon, grandmother, great grandparents, an aunt and uncle, and family friends. He was born on June 12, 2006 with multiple medical conditions: a cleft palate and heart problems that required extensive surgeries. His immune system is compromised and he is a high-functioning autistic child. He recently developed some blood sugar issues. Yet with all these health and developmental problems, Zachary is happy and loves to be hugged and touched. He loves music and has a high energy level. He is a whiz playing games on his mother's telephone. His mother, Tricia Cannon, home schools Zachary. Even with all of his issues, Zachary is now learning to read and count. You will find he is a happy child and a real little charmer.

The Lodge treated the family to dinner and then presented Zachary with an Android Super pad to help with his schoolwork and to enable him to play games and puzzles. In addition, he received some Disney Pixar 2 cars and a launch pad racetrack. The Elks presented Tricia with a dozen roses, a plaque and a Special Child Pin. A commemorative group photograph was taken. The members really enjoyed meeting Zachary.

A letter from a grateful parent

Dear Elks.

I am writing to express our gratitude for the tremendous benefit we have received from the California-Hawaii Elks Major Project, Inc. We have seen a remarkable transformation in the feeding of our 17 month old little girl, Olivia, since working with the very talented Occupational Therapist, Paula.

At a young age Olivia showed signs of poor growth; checkups at the pediatrician's office were often discouraging as we learned her weight percentiles declined at each visit. Mealtimes were challenging and frustrating. Olivia did not want to sit in her highchair, had little interest in eating and would not drink. Trying to coax food into her was time-consuming and stressful; meals often lasted an hour, with little food actually consumed. We followed doctor's advice to bulk her up with extra butter and olive oil. But it wasn't enough, something was wrong. Consultations from the Gastrointestinal Department at Children's Hospital offered limited help; this was not a medical problem. Thankfully, our pediatrician recognized the need for OT intervention and referred us to Paula.

Over the course of three months, Paula's professional expertise, patience, guidance and keen sense of how to reach a child have made all the difference in helping Olivia. Paula offered insightful recommendations on how we could best help our daughter. With Paula's help, we constructed a positive home program to practice between meetings. Over the course of our weekly lunch sessions, Olivia learned that through experiencing her food's texture, smell, and color, eating could actually be enjoyable and relaxing!

What does mealtime look like now for Olivia? The once frustrated little girl who would reject nearly every food offered and would cry through a feeding is now happy to partake in the family meal. She will sit willingly, she will try countless new foods, she will eat independently, she will drink her milk (even request it excitedly) - in short, it is almost like watching a different child in the highchair. Ordinarily, these may seem like simple milestones. For us, they mean so much.

I am glad I don't have to imagine where we would be today without the expert guidance of Paula and your program. Sincere thanks and heartfelt appreciation to the Elks for their support of this much needed and valuable program!

As the 2011-2012 Lodge year comes to a close and I pass on the duties of

For me, one of my most rewarding experiences was researching membership manuals and statistics and revising and creating manuals. This knowledge gave me the ability to write inspirational, educational, and motivational articles and to share personalized success stories with members of the Association, their families and friends. It was indeed a challenge and a privilege to deliver inspirational presentations to the new Vice Presidents, Leading Knights, Exalted Rulers, Officers and Committeemen at the Association Conventions and Mid-Term Conferences.

To the new Association Membership Chairman, I offer my utmost congratulations. It is my hope that your year will be as gratifying for you as it was for me serving on this committee, and may you always be blessed under the new administration.

Congratulations are in order to Brothers James D. Warrick (Fair Oaks, CA) and Bob Svedeen, PER (Redding, CA). They each received an Elks Watch from the Grand Lodge for recruiting 11 new members, and their efforts have earned them a chance to win a trip to the Grand Lodge session in Austin, Texas in July, 2012.

In closing, I am pleased to report that, as of the end of February, our membership change percentages range from a negative 0.49% to a plus 8.60% - an average percentage gain of 2.94%. In terms of total membership gains and losses, we have 18 districts showing net gains and only 1 district showing a net loss of less than 0.50%. The membership percentage gain rankings of the top three districts are as follows: San Gabriel Valley 8.60%, South Central Coast 7.76%, and Hawaii 7.39%. Keep in mind that this is the February report. We still have the month of March for the completion of the 2011-2012 Lodge Year.

Vallejo Elks Lodge No. 559 awards \$5,000 in scholarships

The Vallejo Elks Lodge No. 559 awarded scholarships to eight local area graduating seniors. Lodge members presented the seniors with scholarships sponsored by memorials to deceased members of the Lodge. Oakhurst Elks Lodge No 2724 and Madera Elks Lodge No. 1918 help wounded warrior

The Oakhurst Elks Lodge No. 2724, the Madera Elks Lodge No. 1918, the VFW Post No. 8743 and the Marine Corps League Griswold Mountain Detachment No. 1121 teamed together and held a fund-raiser for Marine Corporal Toran "Chance" Gaal, who had lost both legs in Afghanistan. It was held on Saturday, February 4, 2012 at the Oakhurst Elks Lodge. The funds that were collected from that event were presented to Chance's grandparents. They raised \$11,345, which was given to the Semper Fi Delis fund in the name of Chance Gaal. Chance will use this money for his and his family's expenses, as he is currently in San Diego being fitted for his prosthetics. He wants to run, not walk.

Chance had reenlisted for another four years so he could deploy to Afghanistan in March 2011, after having served previously in the Presidential Guard under President George Bush. In Afghanistan, Corporal Gaal was an infantry rifleman in 15 Charlie Company with the 1st Battalion, 5th Marine Regiment, 1st Marine Division based out of Camp Pendleton in San Diego. He was injured during an attack in Afghanistan's Sangin District of the Helmand Province, one of the country's most dangerous regions. Chance was critically injured from an Improvised Explosive Device (IED) on June 26, 2011. His wounds included the loss of both legs and some of his right hip. On August 11, 2011, the Yosemite High School basketball star and 2005 graduate received the Purple Heart medal from General Joe Dunford. The first thing Chance told that General was, "Don't kick me out." That's a part of how they train these guys. That's part of being a Marine. They never want to quit. That's why they say, "Once a Marine, always a Marine." Chance still wants to remain in the Marine Corps following his recuperation.

At the fund-raiser, Supervisor Tom Wheeler, representing the County of Madera Board of Supervisors, awarded Corporal Gaal a Certificate of Appreciation for his service to our country. The Yosemite High School Cadet Corps, the Marine Corps League and the Veterans of Foreign Wars all participated in making the event a success. The Cadets presented the colors and the Marine Corps League Chaplain gave the benediction. The American Legion of Merced bikers, and a group of bikers from Clovis, did a Parade of Colors. It was quite a patriotic site to see.

In addition, since Chance's 25th birthday was on February 17th, the Oakhurst Lodge sent him a birthday card signed by numerous Lodge members, and a 2,000 piece jigsaw puzzle of El Capitan in Yosemite, which is located near his alma-mater.

Insurance and Safety

Fellow Elks, we have entered a new Elks year with many of the same issues that we closed with last year. The great part has been that, from an insurance and safety point of view, we (the California-Hawaii Elks Association) have had minimal insurance issues. Since we are the largest of the Order's State Associations in the United States, this means that CHEA has played a large part in helping to keep the Order's insurance programs affordable.

I still feel the need to make a few reminders so that we may continue to maintain our safety and insurance standards:

- 1. Every Lodge must have an Accident Prevention Manager appointed from the Board of Trustees. This is required under Grand Lodge Statute 12.070. This person should be familiar with the Accident/Claim Prevention Manual and the Liability Insurance Booklet. This knowledge, along with good old fashioned common sense, will help keep your Lodge safe for your Members and their guests, and will help to protect the Lodge's physical assets if an accident should occur.
- 2. A reminder to the Lodge Secretaries and Board of Trustees you should have your budgets in place by now. But, did you remember that all Grand Lodge Insurance programs are now effective on April 1st?
- 3. Questions remain concerning the \$5,000 no-fault clause that has been eliminated from the Liability policy. As of 4/4/11 the "no-fault medical payment" NO LONGER EXISTS. Yes we will no longer pay claims on a NO-Fault basis, so if you have a medical claim that you would have previously just paid off SUBMIT YOUR CLAIM to Gallagher Basset (no matter how small), and DOCUMENT DOCUMENT DOCUMENT. Review your Claims Manual for details.
- 4. Worker's Compensation Insurance: This will always be a thorn in the side of business, but it is a necessity. The smallest claim can mushroom into a nightmare costing thousands of dollars if it is not properly handled or if there is no insurance in place. A claim can bankrupt a Lodge. Contact me or your District Chairperson if you require more information or if you are renewing your insurance and need a reference.

When we talk of Insurance and Safety we always have to take into consideration the legal issues. If you, as a Lodge Secretary or Member of the Board of Trustees, are considering construction work (no matter how small or large), or are entering into any contractual agreement, even with the local Chamber, Bingo group, cell tower company or caterer - before signing on the dotted line, consult with your local or Lodge's legal counsel. It is cheaper and easier up front than fighting the nasty battle later over an issue that might have seemed small at the time.

Let it be a Great and Safe Elk Year.

This time of year is very rewarding for the CHEA Scholarship Chairman. It is the time of year that I receive thank you notes from students that were awarded scholarships in the 2012-2013 Most Valuable Student Contest. These students are very appreciative and the MVS Scholarship program reaffirms the Elks commitment to support our youth.

There is another program offered to students in California-Hawaii – one that is available all year long. It

is the Vocational Grant Program. This \$1,000 grant (renewable for a second year) is available to anyone, of any age, that is a Citizen of the United States. The applicant doesn't even need to have a high school diploma. Last year, we created a budget for 81 Vocational Grants—but we only awarded about 30% of that budgeted amount. There was money left on the table at the end of that year that could have been awarded to students in your area to help with their education.

Some Lodges complain that there is a shortage of students in their area that can qualify for the MVS contest. The Vocational Grant program is a program that has very few requirements beyond the need to be a U.S. citizen. It is designed to help an individual learn a trade. Stockton Elks Lodge No. 218 and Lodi Elks Lodge No. 1900 present Americanism Essay awards


