#### Chula Vista Elks Lodge No. 2011 members donate blood

The Chula Vista Elks Lodge No. 2011 participated in a combination Health Fair and Open House event during the month of July 2014. The San Diego Mobile Blood Bank was there that day. Of the 35 people giving blood, 20 were Elk members, 15 people were lodge visitors, and 10 were giving blood for the first time, said Larry Schultheis II, who has been the Blood Bank Chairman for over nine years. The donations were 140% more than was pledged for that day. These 35 pints of blood were immediately used to assist 105 patients in area hospitals that weekend. Chula Vista Elks Lodge members consistently give to the Blood Bank in their area during

### Grass Valley Elks Lodge No. 538 and "Bill's Wheels"

The Grass Valley Elks Lodge No. 538 has a program called "Bill's Wheels." Bill Dobbins (a Pearl Harbor survivor lodge member) has been collecting all kinds of wheelchairs and other items for a number of years. His collection includes everything from canes to wheelchairs for quadriplegics. Bill Dobbins was on the USS West Virginia during the attack on Pearl Harbor and he was on the USS Missouri when the Japanese surrendered to end WWII.

Since the beginning of the program, Bill's Wheels has distributed at least 100 such devices free of charge to those in need. Seventeen wheelchairs have been distributed since April 2014. Some of the chairs are valued at several thousand dollars. These chairs are donated to the lodge. The lodge purchases batteries (in some cases up to \$600) if needed and any other parts required to make them useable.

A family in need will contact either Bill or the lodge. The chair is fitted to the recipient and a lesson is given on the chair's operation. When Bill feels the recipient can safely use the chair, a disclaimer is signed that holds the Lodge harmless and the chair is released. A request is made that if the chair is no longer needed that it be returned to the program. Over the years this program has assisted many elderly disabled veterans.

Over a hundred adults, teens, and preschoolers welcomed them, waving flags, playing drums, and cheering as the caravan made its way to the alpine village.

Elk volunteers and the Rim of The World Blue Star Moms served a delightful lakeside continental breakfast. The veterans boarded several fishing/excursion boats, which were provided by local Elks, VFW and American Legion Members, and the UCLA Conference Center. 

### Kern River Valley Elks Lodge No. 2358 donates dictionaries


