The Elks National Foundation has had another successful year. We have exceeded our Association's donation goal for the year, surpassing last year's donations by more than 5%! More Elks have committed to make recurring donations through the Fidelity Club or an employee/employer matching funds program. The result will be increased ENF funding to the California Hawaii Elks Association Major Project, for our Most Valuable Scholarship Recipients, the

Hoop Shoot and Drug Awareness programs and to the Elks' National Veterans Service Program.

The ENF Community Investment Program has increased the value of each ENF Promise Grant to \$2,500.

Every Lodge that had more than 15% of its membership donate to the Elks National Foundation in 2014-2015 will be eligible for a bonus of \$500 when it achieves the Grand Exalted Ruler's per-member giving goal in 2015-2016. This means that their ENF Gratitude Grant will have a value of \$2,500 rather than the standard \$2,000. This is a more compelling reason for your Lodge members to make regular contributions through the Fidelity Club.

Last year, many Lodges in the California-Hawaii Elks Association received grants from the ENF. There are several grants available to qualifying Lodges: Promise Grants, Gratitude Grants, Beacon Grants, and Impact Grants. It is not only your community that benefits from the good works that are funded by these Grants, but many participating Lodges report an increase in membership as the direct result of the publicity generated by the good work we do.

Thank you for supporting the Elks National Foundation. The Elks are known for supporting our veterans and for their many other acts of charity in their communities. Through the ENF our legacy continues.



Membership Development

There are actions that Lodges may do right now to realize net membership gains in 2015-2016. First, start with a solid Membership Management Team involving Lodge Activities, Public Relations, Membership Development (including Second Step), and Membership Retention. Have the team adopt the Best Practice of Membership Recruitment and Retention Power Points found on the CHEA website. The Membership Recruitment and Retention Power Points outline month-by-month benchmarks for the Membership Management Team.

The Exalted Ruler should appoint an Officer as the Coordinator of the Membership Management Team. The Exalted Ruler, the Lodge Secretary, and the Coordinating Officer should have key roles in working with the Membership Management Team. A minimum of four members should make up the team, which should meet monthly, to carry out the ongoing responsibilities of promoting membership within the Lodge.

To reinforce proven successful approaches to membership gain, CHEA will feature six Membership Workshops throughout the California-Hawaii Elks Association. These Membership Workshops include valuable handouts, the CHEA Membership Recruitment and Retention Power Points, and interactive discussions about Membership issues, unique to a Lodge or common with other Lodges.
