#### Petaluma Elks Lodge No. 901 Acknowledges Police Volunteers

A breakfast was held at the Petaluma Elks Lodge No. 901 in tribute to the Petaluma Police Volunteer Program. There are over 60 Petaluma Police Department members/volunteers (from 15 to 93 years of age) who donate over 4,700 hours a year to increase the health and safety of the citizens of Petaluma. The volunteers and their families were treated to a great breakfast during which different members of the volunteer program were acknowledged for their service. Members of the Petaluma Elks Lodge prepared and served 170 breakfasts to these volunteers and families.

There are three categories: Volunteers, Chaplains and Interns who perform duties that do not require sworn police officers. Some examples of these duties are: delivering papers/reports to the County Court House or Petaluma City Hall, driving vehicles for maintenance or update of equipment, taking cars to the car wash, and performing traffic control at events. The volunteers receive no compensation for their time spent except that their uniforms are provided by the Police Department.

PDD members have created task force teams that provide year round support inside and outside of the department. In addition to receiving volunteers from the local high schools, Santa Rosa Junior College, and the greater community (Elks are volunteers too), they have Interns from Sonoma State University who are studying Criminal Justice and Chaplains. The PPD offers Junior Police Camps, an Explorer's Program and a Community Academy.

Members, as the Elk year comes to a close, it would appear that our Association will once again show its benevolence toward the Elks National Foundation as we continue to give generously to the endowment fund. On behalf of the "Great Heart of Elkdom," I thank you for all that you have done.

As the ENF Endowment Fund continues to grow, its contribution to our communities continues to grow at an even faster rate. All of the ENF sponsored programs:

Scholarship, Hoop Shoot, Drug Awareness, Veterans and Community Investments Programs have been revamped to receive more funding.

Our three ENF scholarships, the Most Valuable Student, Legacy Awards and Emergency Educational Grants, help more than 3,100 scholars attend college annually. The Community Investment Program grants \$9,300,000 a year to Elks Lodges to enable Elks to better serve their communities. ENF youth programs, Hoop Shoot and Drug Awareness encourage competitive healthy lifestyles. The Elks National Veterans Service Commission provides aid and comfort to our nation's veterans.

This year, the ENF will spend \$28.95 million on our programs, building stronger communities nationwide. This is a return of \$3.38 for every dollar donated by Lodge members to the ENF last year. Our California-Hawaii Elks Association Major Project will receive substantial support, as over 30% of the national ENF budget is awarded as grants for State Association Projects.

The Elks National Foundation Fidelity Club, a monthly giving program, recognizes giving via automatic, regularly scheduled payments. Eligible donors have a monthly minimum or quarterly minimum payment deducted by credit or debit cards. # San Luis Obispo Elks Lodge No. 322 Provides Holiday Cheer to Veterans

Three families from Camp San Luis Obispo received holiday support from the San Luis Obispo Elks Lodge No. 322. Seven children received toys on their wish lists marked "From Santa", a "goodie bag" filled with candy and an ornament engraved with their names. Each couple received a \$30 Sears gift card, a \$15 Vons card, and a box of food. The total value of these items was \$513.34.

Gary and Donna Donovan collected and delivered donated items valued at \$14,000 to the veterans at the Fresno VA Hospital and the Fresno VA Community Living Center/Rehab (CLC). Each veteran at the CLC received a sweat outfit, a "goodie bag", and a Christmas card. Some other items that were donated included hand-knitted lap afghans and hats, coffee and supplies, playing cards, reading glasses, puzzle books, socks, and assorted toiletries.

Coffee, creamers, and sugar/sugar substitutes valued at \$95.83 were donated to the SLO VA. Gloves, body wash, toothbrushes/paste, socks and knitted caps were also donated to the SLO VA clinic for 100 homeless veterans. For the hypoglycemic fasting diabetic patients, snacks of orange juice cans, assorted crackers, and peanuts were donated. Also coffee and supplies and candy canes were donated for their coffee/snack cart (valued at \$1,516.46). A box of goodies was mailed to the Lodge Inner Guard stationed in Kuwait (\$64.94).

### Why wasn't my photograph included? A note from the Editor

Sometimes a photograph isn't included because there isn't room. Generally, there are other reasons not to include a photo. The biggest factor is the quality of the picture. Pictures taken with a cell phone are often of poor quality – perhaps good enough to email to someone or post on a web site, but often these are not good enough to be considered for publication. Please refer to my editorial guidelines at http://www.cheaelks.org (click on "CHEA Magazine" at the top). Please note that I want electronic photographs, not hard copy prints.

Sometimes the photo is just too blurry, is poorly composed (subjects are too far away), the lighting is poor (too dark, too light), or the camera has put a date stamp in the picture. Also, it is important that the photo illustrates the story that your article is describing.

Photos taken with a digital camera (or cell phone) need to have the settings adjusted so that the photo is of the highest quality. The camera should have at least a 4 megapixel capacity (the more, the better). Check your camera settings—look for a setting that will give the greatest number of pixels (must be greater than 1,500 x 900 pixels, or dots per inch, but the more, the better). Good quality digital cameras can be found for well under \$100 these days.

If I publish a photo with an article, I will only publish ONE photo. I'd rather YOU choose that photo, not me. So, please just send me the ONE photo that you feel best illustrates your story. If you send me half a dozen pictures of your event and expect me to choose one, it may not be the one that you'd have chosen.


In other news, the ENF First place 2015/16 MVS scholarship winner Mark Ansell and his identical twin brother Andrew, also an ENF winner, joined the CHEA Scholarship judging committee assembled recently in Fresno. They were invited by CHEA Scholarship Committee Chairman Jan Bennett to attend the last day of the three-day judging session. They were promptly put to work assisting the committee with the 390 applications received. At day's end, 72 California and Hawaii applications were sent on for judging at the national level. A total of 500 finalists from all State Associations go the Grand Lodge for judging. In late April, the twenty top finalists will interview with the national judges. These twenty finalists will be vying for two first-place awards of \$50,000, two second-place awards of \$40,000, and two third-place awards of \$30,000. The remaining fourteen finalists will each receive awards of \$20,000. The 480 runners-up will receive fifth-place scholarships of \$4,000 each. Chairman Bennett thanked the 35 members of the CHEA judging committee and said, "In addition to the 72 going to National, we will be sending letters of congratulations to about 276 students who, though they did not go on to National, will receive an award of \$800 from CHEA and also 114 awards for placing 1st, 2nd, or 3rd in their District.'

#### **Drug Awareness**

According to research conducted by The Partnership for Drug-Free Kids, as many as one in five teens say that they have taken a prescription drug that is not their own. This behavior cuts across geographic, racial, ethnic, and socioeconomic boundaries.

Teen drug abuse occurs for a variety of reasons. Stimulants such as Ritalin or Adderall are abused to obtain additional energy or increase the ability to focus. Pain relievers such as OxyContin and Hydrocodone are

abused to cope with social or emotional stress. Abuse occurs with amphetamines and steroids to lose weight or to "bulk up."

The majority of teens abusing prescription drugs are getting them from the medicine cabinets of friends and family. Some teens "traffic" the drugs among themselves by handing out or selling their own prescriptions or medications that they have obtained illegally over the internet.

How can we help?

- Educate yourselves and your family members.
- Communicate the risks of prescription drug abuse to your children and grandchildren.
- Safeguard your own medications Remember that any medication can cause harmful side effects when used by someone other than who it has been prescribed for.
- Be sure to lock up or place out of reach all medications if you have small children who may be spending time in your home.
- Know what is in your purse or pockets. Many pills look like candy and may be accidentally ingested by children. Children are curious!

The Elks Drug Awareness Program has information on Prescription Drug Abuse and how to start conversations with your children and grandchildren. Check with your Lodge Drug Awareness Chairperson. All of our pamphlets and informational materials are free to any individual or groups who request them.
