# Paradise Elks Lodge 2026

On behalf of Paradise Elks Lodge 2026 of Paradise, California, our Officers and Members, we'd like to thank all our fellow Elk brothers and sisters who donated so generously. The phone calls, messages, and Facebook notes that began within days of the Camp Fire was, well, just unbelievably heartwarming. There has been such an outpouring of love and support from Lodges North, South, East and West, and all points in between. We are so grateful and proud to be Elks!

At the time of the fire, our membership totaled 454. We are currently at 462. We did lose one of our best widowed volunteers. She was 95 years old. We estimate that we lost approximately 390 of our members and officer's homes. Some of who rented homes and had no renter's insurance. The devastation is unfathomable and our members have been scattered near and far. We are still attempting to locate everyone.

Imagine leaving your home for the day and not being able to return. There's nothing to return too. Not only have you lost your home, but your neighbors, friends, doctor, dentist, school, daycare, local grocery store, corner gas station, bank...everything you knew, everything that was familiar and safe, gone.

Our goal is to return to Paradise as soon as possible where we will open a temporary Lodge. Our desire is to be able to have somewhere for members, as well as potential members to congregate and have a sense of community.

We will eventually rebuild on our property. It's definitely going to be a process. Our insurance will cover the Lodge building. It's our members that we have been focused on taking care of. Because of the outpouring of love and support, 100% of all donations are strictly for our members.

So, for all that has been donated, whether it be clothes, bicycles, bedding, toys, furniture, Elk jewels, Elk antlers, pins, Bible, gavel, and gift cards, *WE THANK YOU!* Elks Care, Elks Share.

#### **Elks National Foundation**

As spring turns into summer, change is in the air. We have begun a new Elk year; new Officers, membership totals are up along with the excitement of revitalizing our Lodges and Association. With the increase in membership should be an increase of per member donations to the Elks National Foundation.

I don't have the final end of the year numbers as I write this article for ENF. Totals are as of March 26, 2019 and we are a little off from last year but not much. I'll wait for final numbers to comment more. Currently, the Association is at \$10.410 per member and total donations of \$892,056.78. But the Bequest and Living Trust donations are way up thanks to two donors in the Bay District. As soon as Grand Lodge in Chicago finishes the processing to close out 2018-2019, I will send an email wrap up to all the District ENF Chairs. I ask you to share that with your district membership when received.

Officers as you continue on this year's journey remember the oath of office you so recently took. Translate it over to how you could help improve the totals of the Elks National Foundation. For example, the Exalted Ruler has laced in his oath definitions of Fidelity. Fidelity implies strict adherence to the principles of our Order and therefore demands that we, as Elks, will be good exemplars of these principles in our daily lives. Exalted Ruler could you not, be a good exemplar by leading your Officers in a donation to the Elks National Foundation. Make a \$10.00 donation. The benefits are huge and help so many plus part of that money comes back to our CHEA State Association. That's huge! Along those same sentiments is a reminder in the verbiage of the installation ceremonies that remind us that each lodge is one of the fraternal links in the great chain of Brotherhood that constitutes our Order. We must join together with this mutual respect for our programs and our Orders good works. It's for the kids, the veterans and our communities at large.

Since inception in 1928 through March 31, 2018, the Foundation has granted a total of \$43,959,192.10 to our CHEA Association, compared with our state's total donations of \$39,183,856.08. That's a ratio of 1.122 for every dollar the Foundation has received from our state.

The Foundation's past support includes:

- \$20,504,534 in State Charities Grants
- \$8,932,092 in Special Projects Grants
- \$9,966,107 in "Most Valuable Student" Scholarships
- \$469,637 in Emergency Educational Grants to the children of deceased or totally disabled Elks
- \$796,500 in Legacy Award scholarships to the children and grandchildren of California-Hawaii Elks.

Please keep your donations coming. Let's see if we can beat our totals from last year. With your help I know we can do it. Your generosity never goes unnoticed. Keep up the good work!

San Jose Lodge 522 Ladies of the Elks held it's annual Fashion Show and Luncheon with all the proceeds benefitting the CHEA Major Project. Twenty six models, three clothing stores, 167 attendees and over 70 volunteers came together to raise over \$8,500.

Garden Grove Lodge 1952 Project Dignity founded in 1991 by Linda Dunlap with a mission to assist homeless families in our community by providing support with motel accommodations until the working family can afford to move out of their motel. Currently supporting over 2,000 homeless population Project Dignity is now serving over 500 families at 20 motels monthly with 200,000 pounds of food. In addition to food and clothing, they also supply hygiene items, baby care items, school supplies, medications, gift cards and rent. The Lodge in this fourth year contribution is providing 80 backpacks with a box of school supplies through the Garden Grove Elks Beacon Grant and the cumulative total has been 386 backpacks with supplies worth \$9500 to date.


The reason I am encouraging everyone to stop by the booth is so that we can meet you, thank you for everything and offer you an opportunity to walk away with big, I mean really big prizes.

# 2019 Theme Child California-Hawaii Elks Major Project, Inc.



Though he didn't speak, Liam captured my full attention when I first met him. His dark, searching eyes and subtle smile instantly drew me in. Here was a child who was very physically limited, who just couldn't seem to get his body to do the things he was trying to make it do, like reach out to his mother, pick up a toy or sit on his own. Yet he patiently watched all the activity around him and seemed to enjoy watching his family go about their daily routine. Mention "the girls", Liam's school aged cousins, and a great big smile spreads across his face. Liam loves his family and the life around him, and his family loves Liam, always making lots of time for cuddles and sweet conversations. Oh, but to be able to join in some of the hustle and bustle. Liam had that unmistakable look of determination. I knew he wanted to work, but it would not be easy for him.

Liam was born full term at Clovis Community Hospital following a non-complicated pregnancy on July 12, 2015. His delivery was fast and his initial APGAR scores were good, however one to two hours later he went into respiratory distress and developed a systemic infection. He spent 8 days in the NICU before going home. When Liam was only a few months old his parents began noticing he was having difficulty with head control and pushing up onto his arms. He continued to

grow but was not gaining age appropriate skills like crawling or sitting up. Liam also started exhibiting abnormal muscle activity and began having seizures. Liam was referred to specialists who began monitoring his condition. Last May Liam was diagnosed with a rare neurodevelopmental disorder due to a genetic mutation on the RHOBTB2 gene, a mutation which had just recently been discovered and published in The American Journal of Human Genetics in January 2018.



Liam started physical therapy when he was 6 months old but made little progress. Living in rural Mariposa County with limited resources, Liam's family had to travel an hour each way to get to physical and occupational therapy in Fresno. Liam had difficulty transitioning from the travel to participating in therapy. His physical therapist recognized that the hour long car drive was draining for such a young child, and referred him to the California-Hawaii Elks Major Project for therapy in the home. Liam initially began occupational therapy through the Elks Major Project with an emphasis on feeding therapy, and began physical therapy with Lea Nibur in September 2017 when he was just over 2 years old. He is now engaged and receptive during his therapy sessions and he has made continual progress.

When Lea first met Liam he could not get onto his hands and

knees, sit up, or control his head well. He got tired very easily and often cried during therapy sessions. We have worked very hard on strengthening, balance, mobility on the floor, and skills such as reaching for toys, pushing toys, and bearing weight through both legs. Liam's mother reports that when Liam is playing in his room, she sees him practicing many of the skills he learned in therapy. He now rolls and army crawls to get around his room and loves to play under his bed. He enjoys spending time in his stander in the family room playing with toys and spending quality time with his adoring grandparents. He also loves afternoons with his cousins who sing and play games with him after school. In therapy Liam is now able to sit, hold his head up, and push up onto his hands and knees, all with just a little help. On his hands and knees Liam is able to hold himself steady while reaching for toys with one hand and he is starting to push himself up into a sitting position from the floor all by himself. Liam now smiles and laughs as we work! He will reach deliberately for toys or point to parts of his body when asked to and is communicating with facial expressions and hand gestures, such as giving a thumbs up to let us know he is happy and approves, or signing I love you to his mother. Liam has gained notable strength and stamina, is eating and gaining weight well and has begun going to school for a few hours each week. He works hard in therapy and practices his new skills and home program exercises throughout the week with his parents and grandparents gently guiding him. He continues to grow and develop new skills and delights us all with his quiet but mighty inner strength and determination.

It is the end of the 2018-2019 Lodge year, and it is a very busy time for secretaries. Dues are coming in, and notices to delinquent and lapsed Members are being mailed. Secretaries are busy getting information together for the audit, trying to get those last few new Members initiated and finishing up their Charity Reports.

Charity Reporting is essential to the well being of our Order. It protects the status of your Lodge, and Grand Lodge, with the IRS. The Charity Report is the only tangible report of what we do, and it can be used to grow your Lodge by letting everyone know how much it contributes to your community.

Now is the time to take a long hard look at those entries. Do you have everything entered? Has all of your Committee Chairs reported? Did you include Lodge and District Meeting hours and miles? Convention hours and miles? State Projects? Now is the time to get out the Government Relations Manual and check the list of everything you can report and see if you may have missed something.

We hope that 100 percent of our Lodges report this year. Last year we had some that failed to report, many of which listed items but simply failed to hit the submit icon. If you take the time to enter data then why not submit it? If you are an outgoing secretary, go over the reporting with the new incoming secretary.

Last year we reported \$675,985,245. Can we beat that number? I believe we can. The ground work was laid and there is much more we can report. Start now, because the submission date is coming up and we don't know if that date will be extended. Why wait? Finish your report and get it submitted as soon as possible. If you have any questions, download the Government Relations Manual at elks.org or contact your District or State Government Relations Chairperson.

If you have not been filing a 990T with your 990 to the IRS, please take the time to speak with your accountant regarding Unrelated Business Income Reporting. It is in the best interest of your Lodge to report this income. The information is in the Grand Lodge Government Relations Manual.

Lastly, a big thank you to all those Officers who worked so hard to make 2018-2019 a success in your Lodges, Districts, and State Associations. Your service and hard work is appreciated. To those newly elected Officers who will soon be taking over the reins of leadership, thank you for stepping up. We wish each of you a successful Elks year.

Palm Springs Lodge 1905 acknowledged Liam, who was awarded the rank of Eagle Scout as a member of the Lodge's Scout Troop 262. Liam's Eagle project was sewing and providing hearts for the babies in the Neo Natal Intensive Care unit at Desert Regional Medical Center. The basis for the project is, when a baby is born pre-mature they are placed in an incubator which is a capsule like device that keeps them safe from bacteria that may harm them. While they are in the incubator, they can have close to no contact with their parent or the outside environment. A Soothing Heart is an 8" x 5" two-sided fabric heart that is given to the parent of the pre-mature baby with instructions to wear it on their skin overnight and bring it back to place it in the incubator with their child. The two sides are made up of cotton flannel and minky fleece. These two different textures help develop the child's ability to associate touch with feeling. The purpose of having the parents place it on their skin or wear it overnight is because the heart will absorb their individual scent. When the child is exposed to the scent of their parent, they not only stay calm, but they also grow closer to their parent emotionally and feel less pain and eat better. Items such as the Soothing Hearts are proven to help development and heal a pre-maturely born baby physically, emotionally, and mentally. Liam's project provided 3000 Soothing Hearts to the Desert Regional Medical Center Neo Natal Intensive Care Unit.

# **Insurance and Safety**

As the new Lodge year is getting under way, now is an ideal time to examine the well being of the Lodge.

The Property Plus certificates of coverage for the fraternal year 2019/2020 should have arrived in April, renewing the existing coverage

for the Lodge buildings and contents effective April 1, 2019. The certificate of coverage will outline the deductible per occurrence, the limits of coverage, and the location of the property. It is of the utmost importance that these certificates are reviewed for accuracy. Verify that all Lodge buildings are covered, and that the limits of coverage are adequate in the event of a loss. If there is a discrepancy, AON will need to be contacted. Contact information for AON, as well as the Property Plus Insurance Guide which explains the coverage provided, can be found on-line on the Safety & Insurance page of the Elks website, elks.org.

Flood and earthquake coverages are not included in the Property Plus Program. If a Lodge has a need for this insurance, quotes would need to be obtained to determine the most cost effective carrier.

The Liability Insurance Program coverage also commenced on April 1, 2019 for each Lodge. The Master Liability provides coverage for general and contractual liability. The coverage does not include any type of motor vehicle coverage. A Lodge should not own a motor vehicle, but if it does, a separate motor vehicle policy would be necessary. The updated Liability Insurance Program booklet outlining the program and coverage is also available on-line on the Safety & Insurance page of elks.org.

The Master Liability Program does not cover claims alleging sexual harassment, discrimination, or wrongful termination. For protection against these types of claims, a Lodge would need to purchase a separate Directors and Officers (D&O) policy.

Grand Lodge Statute 12.070 requires all Lodges to establish an Accident Prevention Program and designate an Accident Prevention Manager. A Lodge should have an established accident prevention protocol in place, complying with all applicable state laws. All Officers and Lodge members should know the process to follow should an injury accident occur.

In the interest of accident prevention and safety, please be reminded that the service of alcohol is a privilege a Lodge extends to members and their guests. Ensuring that anybody serving behind the bar has been LEADs certified is a safety protocol that CHEA has put in place for the protection of this privilege. Establishing a pattern of safety by education and responsible actions is a best business practice that will ensure the continued viability of a Lodge. Cutting off a member or guest appropriately is better than defending a lawsuit, and may even save a life.

Finally, matters of coverage can be quite convoluted. Please feel free to contact me should you have any questions or concerns.




