To the Officers and Members of the California-Hawaii Elks Association

My fellow members,

During these difficult times, the California-Hawaii Elks Association has had to make many changes to try and keep our members safe. The most important consideration in today's world is to follow our Government Regulations and the advice from our Healthcare Professionals. Because of the COVID 19 situation, the CHEA Convention that was to be held in Palm Springs in May has been cancelled.

A number of steps have now been taken to keep our members safe and to ensure Elkdom will continue once this crisis is behind us. I would like to share some of the steps with you that are being taken at this time.

Our Association President Tim Jaeger and First Vice President, Jay Larkins will remain in office for the coming year. Jay's Vice President Designates will work along with the current Vice Presidents (who will remain in office throughout the next fraternal year). All other Association Officers such as, our CHEA and CHEMPI Board of Trustees, Association Committee Chairmen and Vice Chairmen will change positions per usual on May 16, 2020 because they can work remotely from home.

It has been decided that Association President Jaeger will not make any District Visitations during the upcoming Fraternal Year of Elkdom. The reason for this is that Tim has already made all of his designated visits. It will relieve the Districts of the responsibility of hosting an Association President.

Also, the current Vice Presidents will remain in office but will not do any District Lodge visits. They will submit the reporting forms to the Lodge electronically. Then the Lodge will fill it out and return it. This will relieve the burden of Lodge visits in the coming year. Part of the reasoning here is that once the quarantine has been lifted, many Lodges will probably find themselves in some sort of financial difficulty. This will give the Lodge leadership the opportunity to regroup and get their Lodge in working order again.

You will find other information in this publication regarding the Convention refunds and the steps we are taking to ensure our Major Project continues into the future. Please make sure you read through the magazine to get further information.

It is not only Elkdom that is facing trying times, but our entire world. The most important thing is to keep our membership safe and healthy. Our Lodges have been closed due to the pandemic. Once they reopen, it will be necessary for truly dedicated Elks to step forward and help carry their Lodges successfully into the future. It is the Lodges in their local communities that will carry forward the charitable works of Elkdom that will be needed now more than ever.


That is it for now, keeping it short, we all have so many other things to concentrate upon.



Membership Retention and Lapsation

Greetings, I hope you and yours are safe and well during these unusual times. The State of California is under "Stay at Home" orders and I believe Hawaii has a similar restriction. Unnecessary travel has been prohibited, the schools are closed and people who can, are working from home. Our annual Convention has been

canceled and most, if not all, of our Lodges are shuttered and operating with the office staff only.

I don't know if any of us has faced the uncertainty that confronts everyone now. The Coronavirus is a worldwide pandemic, and no one can predict Its duration or the damage it may do. This has brought a host of issues to the table and put us all in an uncommon position, now it is up to each of us to make of it what we can.

Recruitment can go forward with electronically submitted applications. Interviews and Orientations lend themselves to technologies such as Skype, Zoom, Face Time, Duo and others. These will allow personnel, face to face interaction with the Candidates and eliminate any travel or social distancing issues. A Lodge of one hundred or more members can hold a meeting with a quorum of nine members, two of whom are elected Officers and conduct the normal business of the Lodge. Again, this can easily be done with platforms such as Zoom, Go to Meetings and others.

The question of how we Initiate is still not fully resolved but I expect guidance on that forthwith.

As far as addressing Retention and Lapsation are concerned we have the tools at hand. The Lodge Secretary should have began mailing the monthly late dues reminders already. These reminders in the form of late notices, letters, greeting cards or whatever you choose, need to go out the first of every month. With Lapsation, make the phone calls now. As of April 1st, we began our sixty-day penalty free Reinstatement Period. This allows any member dropped as of March 31, 2020 to be put back on the Rolls simply by bringing their dues up to date. Those recovered will count towards our 2019-2020 Membership total.

All is not a struggle and gloom, and although CLEMS will not have the official numbers until late June or early July, I feel safe in predicting another plus membership year. I don't believe it will rival last year's numbers, but given the virtual loss of the last two weeks of the year, it should nevertheless be respectable.

Lastly, remember, Membership means participation and Brotherhood. Be sure all your members know whom to call should they have a question or need assistance. Stay in touch with the Candidates and keep them abreast of their progress towards membership. Make the members aware of what's transpiring and what may be on the horizon. We have mass mailing bulletins, Facebook, e-mail and other media at our disposal, we need to stay in touch as much as is practical.

Most of all, reach out to each other and offer what help you can during this strange time. The Cardinal Principals of our Order should guide you at this time more than ever.

Aaron is an adorable 5-year-old boy. He is energetic, funny, affectionate and rambunctious. So basically, Aaron is a lot like many 5-year-old boys keeping their parents on the run. What is not so typical is that Aaron is not yet using many words to make his wants and needs known.

The most intensive period of speech and language development is during the first three years of life, a period of rapid brain development. At about 12-months-old, many children are already using single words, and by age 2 may be putting words together in simple sentences.

Aaron's parents noticed early on that Aaron was not using simple words or pointing to direct their attention. Aaron was also a bit delayed in walking so he was receiving physical therapy in his home through The California-Hawaii Elks Major Project. Aaron's physical therapist, Megan Macleod, suggested that Aaron receive a speech/language evaluation and referred Aaron's parents to Toby Tamayo-Davis, speech language therapist with the California-Hawaii Elks Major Project.

Toby evaluated Aaron when he was approximately 18-monthsold and determined that he would benefit from individual speech language therapy. She immediately began working with Aaron and his parents weekly in his home. Speech language therapy sessions included using pictures, books, songs, toys and lots of repetition. Aaron was making slow but steady gains due to speech language therapy, but Aaron's parents felt that there was something more than just a straight forward speech language delay, and had Aaron undergo further diagnostic testing.

At the age of 2 years, 9 months, Aaron was diagnosed with Autism Spectrum Disorder (ASD), which is a developmental disability that often includes challenges with communication. The term "spectrum" refers to the wide range of symptoms and skills that children with ASD may have.

Toby was the perfect therapist for Aaron due to her extensive experience as a speech therapist working with children with ASD. She educated and empowered Aaron's parents with a home program so that they could be involved in Aaron's speech language therapy all week long, not only when Toby was there for his therapy session. Aaron's parents were outstanding with following through with all home program suggestions made by Toby, and eventually began seeing improvement in Aaron's ability to communicate both verbally and non-verbally, in his play skills and his ability to follow a routine. It was a lot of work, but certainly a labor of love. But the generosity of the ELKS was about to get even more significant for this family.



Aaron's mother, Gabby had a baby girl, Sarah, in December 2016. A baby sister for Aaron! During the pregnancy Sarah was diagnosed with non-immune hydrops. This is a very rare but serious condition and Sarah was transferred to the Neonatal Intensive Care Unit (NICU) immediately after birth.

Sarah would spend the next 8 months in the NICU due to issues of chronic lung disease, heart problems and needed a feeding tube. While Aaron required a lot of attention due to his diagnosis and therapy needs, the family now had two children with special needs.


Aaron's mother or father were in the NICU with Sarah every day spending hours by her side. If ever a family needed a skilled speech language therapist coming to them in their home for Aaron, it was this family.

When Sarah was discharged from the NICU, is was clear that she would require physical therapy to gain strength and mobility, but she was much too medically fragile to be out of the home for therapy. Aaron's physical therapist through the Major Project, Megan Macleod, was right there to step in and begin weekly physical therapy for Sarah.




It was a chaotic time for the family due to the multiple medical appointments for both children. They were being pulled in a million different directions, but the one constant was both children getting the very important therapy services they needed weekly in their home, all due to the generosity of the Elks. Sarah is now crawling and there is no stopping her!

Aaron still has a way to go, but is using several words and making his needs known. Aaron loves to sing, use gestures to songs, plays on his iPad and loves his little sister.



This family has faced a number of challenges over the past few years, but they are strong and determined to raise happy, functional and independent children. The donations from the Elks have provided Aaron and Sarah the therapy needed to help them reach this goal. A huge "Thank You" to all ELKS

from Hawaii and California for your enthusiastic and selfless fundraising efforts and donations! You are not just helping children with disabilities and their families, but making the world a better place for all of us.



We are so grateful for the speech therapy services for our son Aaron. It gives us such peace of mind to know that our wonderful Elks speech therapist, Toby, will be in our home every week providing Aaron such important therapy. He has made wonderful progress and this is all due to the generosity of the Elks members. Enrique Camarena Winner for 2019-2020: Our Enrique Camarena Winner was submitted by the Petaluma Elks 901 and Drug Awareness Chairman, Pamela Tarango. This year's winner is Brian Wood, an Officer for the California Highway Patrol in the Santa Rosa area and was sworn in on September 23, 2003. He started working road patrol in the Redwood City area. Since he started, he has focused on and maintained an interest in investigations that involve driving under the influence of alcohol and/or drugs. He has also made and directly participated in arrests that include illegal drug possession of drug paraphernalia and possession of drugs for sale and/or transportation for sale. In July 2016, Officer Wood was trained as a Drug Recognition Expert (DRE). This program is sponsored by the United States Department of Transportation,

National Highway Traffic and Safety Administration (NHTSA) for which the International Association of Chiefs of Police (IACP) set the National Standards. In August 2018, Officer Wood was trained as a DRE Instructor. He has assisted at the Drug Recognition Expert certification; taught Cannabis at the DRE School; taught the Marijuana/Cannabis Update to local and out-of-area CHP officers; taught Stimulants and Inhalants at the Drug Recognition Expert School in Petaluma and numerous other classes.

Officer Wood has made over 690 DUI related arrests in his career. This included arrests for driving under the influence of alcoholic beverages and drugs. As a Drug Recognition Expert, Officer Wood has conducted over 70 Drug Recognition Expert evaluations, since his certification in 2016. Officer Wood has also been present as an instructor and witness to many Drug Recognition Expert evaluations.

The Origin of Mother's Day Ritual

The Mother's Day Ritual was adopted early on in the 1900's. At a Session of the Grand Lodge in Boston in 1917, a resolution was unanimously adopted recommending that each subordinate Lodge, on its nearest meet-

ing night to the second Sunday in May of each year, they hold a special service to commemorate Mother's Day.

The following year, at the Grand Lodge Session in Atlantic City, J.E. McCormick of Modesto, CA Lodge 1282 submitted a form of Ritual for Mother's Day. It was voted that this Ritual be adopted as an optional ceremonial for subordinate Lodges.

In 1925 at the Grand Lodge Session in Portland, Oregon the committee on Social and Community Welfare which at that time had charge of matters of Ritual, offered a new Mother's Day Ritual. William Sinek of Chicago Lodge 4 who presented this new Ritual to the Grand Lodge for that committee stated that the entire Ritual was new, with the exception of the tribute which had been incorporated in the Ritual of Brother McCormick and said that the tribute "being very beautiful," remained the same.

He then explained that in bringing "Mother" into the Ritual the one thought that was in the minds of the members of the Committee was that Mother who is with us, as well as the Mother who has passed away, should be considered.

At that Grand Lodge Session a Motion was offered that the observance of Mother's Day by each Subordinate Lodge be made mandatory. This motion was adopted.

Lodge Activities

The Elk year 2019/2020 is behind us! Hopefully, our members are safe, secure, and staying positive. I want to thank those Lodges who have found alternative ways to utilize their facilities and safely conduct the necessary Lodge Activities. Social distancing and technology have proven an effective way of

engaging Lodge membership and supporting our programs. During this period of disruption and uncertainty caused by the COVID-19 virus, our Elks lodges continue to do what they do best: help our communities!

As we move on to a new quarter and a new year, we look forward to returning to the activities that bring us together in the fellowship of the Lodge. The charitable effort of our organization continues on because of the work of each and every Lodge and its membership. Every Lodge activity, no matter how big or how small, helps make a difference for someone, somewhere. It's what we do as Elks!

For the first time in the history of our Order, an unprecedented number of Lodges have had to "go dark." In keeping with shelter-in-place orders, Lodges are complying with local, State, and Federal mandates in an effort to protect the membership. Many Elks members are retired, so fall into the vulnerable category for succumbing to COVID-19. So, what does an active Lodge do to stay connected with its membership during this challenging time?

Concord Lodge 1994 has found several innovative ways to keep members engaged and in touch. First, we subscribed to a teleconferencing service and instituted weekly phone meetings. Officers and Officers-elect were invited to call in. We are able to continue to conduct necessary business, pay bills, and keep everyone abreast of current affairs. The weekly virtual meeting has become quite popular and is well attended.

The Lodge is also preparing daily take-out meals for seniors, as well as putting together food boxes with staple food items and assorted small kitchen items for families in need.

Santa Monica Lodge 906 provided personal hygiene items to homeless veterans.

Santa Maria 1538 is keeping their office open for calls and dues collection with minimal staffing. Also a drive thru system for Lodge dinners has been set up for Mondays and Fridays (March 30 sold out 260 chicken dinners in 20 minutes).

The Lodge is allowing the Santa Maria Food Bank to use their parking lot as a distribution site for meals to the needy. The Lodge also held the drawing for the annual "Harley Raffle," benefitting the Lodge charities, "live" on Facebook.

Santa Cruz Lodge 824 reported that they were able to turn grant money into food gift cards for the staff and patients at the veterans hospital in Palo Alto.

Gardena Lodge 1919 applied for the Gratitude Grant on April 1st and got word that they will receive and donate the \$2500 to our community food bank to help many in need.

Westchester Lodge 2050 had been requested by Cedars-Sinai to do a Blood Drive in April. Individual Elks are offering personal services, (i.e. grocery and RX pick-up, delivery as well as face mask making).

Fremont Lodge 2121 was contacted by the City of Fremont to offer some assistance. The State of California was providing nine trailers to house 18 homeless seniors and/or veterans for the duration of the Shelter in Place. These trailers needed a safe place to set up that could assist with basic hook ups. We have extended our RV area and parking area to make this happen. The Lodge was awarded the Gratitude Grant which the Lodge will use to assist the City of Fremont to help provide meals for not only those sheltered in place at our Lodge. In addition to these above mentioned items, Fremont also has partnered with one of our local restaurants who has always been supportive. Our Community Activities group normally prepares and serves food at one of our local shelters each quarter, but with the Shelter in Place we were faced with the challenge of how to continue to help. The restaurant was humbled to be asked to partner with us on this, preparing meals for those at the shelter and delivering them.

The new fraternal year has begun, thank you to all of you that participated in the Legacy Giving Program in the last fraternal year.

The pandemic puts into perspective what we do as Elks and as a California-Hawaii Elks Association members. I've been a BLT Chairman for many

years in my Lodge and in the South District. In the past I've said (and sometimes even sang a paraphrase of the country song) "Who's going to fill our shoes?" In no recent time have those words resounded as much as they do now in our new normal. One of the great purposes of our BLT program is to insure that the children that we support have the funds to continue their care. So far, we've done a pretty good job but that doesn't mean that we need to stop giving or even slow down...the unfortunate truth is that there will always be children to assist who cannot get assistance elsewhere. This is our commitment, we should be proud.

Over the past few months, a question came up about the donation of stock to the Major Project. Piggy Bank Vice Chair, Cora Woodard, and I put our heads together to figure this out and read the following in the BLT Manual: "CHEMPI can accept both publicly traded securities and closely held securities... Marketable securities may be delivered physically to CHEMPI'S Fresno office with the transferor's (donor) signature or stock power attached." Be mindful that this requires that you have your signature guaranteed with a Medalion Guarantee, available at your local bank if you can get into it. My experience has been that most people hold their securities in a brokerage account... even easier, your broker can definitely assist in the transfer. The securities will, most likely, be sold when received. Closely held securities may have some restrictions that preclude sale, CHEMPI would rule on the acceptance of these securities on an individual

Why would you donate securities? If you've held the securities for a long time, they have probably appreciated. If you sell them there could be capital gain considerations to deal with. Donating them gives you a tax writeoff (contact your accountant for advice) and you avoid the gain.

Stay safe - Wash your hands!

Orange Lodge 1475 participated in a Citizenship Ceremony. One hundred and six children from twenty-three countries became the newest U.S. citizens in a ceremony at the Richard Nixon Presidential Library and Museum. They were born abroad and are claiming U.S. citizenship through their parents. A roll call of the twenty-three countries represented and then the Administration of the Oath of Allegiance. As the program closed, our newest citizens waived the American Flag and sang to Lee Greenwood's song "God Bless the U.S.A." The judging took place in Atascadero, CA over a two-and-a-half-day period in mid-February. One-and-a-half-days were spent reading and evaluating the 353 essays. Every essay was read and graded by no fewer than three different judges.
