



NOTICE OF CANCELLATION OF THE 2020 MID-TERM CONFERENCE

It is with a heavy heart that after many long and difficult discussions a decision has been made to CANCEL the anticipated 2020 CHEA Mid-Term Conference that was to be held this coming November in Los Angeles.

As you are aware, we take seriously our responsibilities to the members of our Association and their families. We want nothing more than to have the opportunity to see our friends in a safe and enjoyable environment, but unfortunately given the recent spike in COVID-19 cases in the Southern California and the resulting uncertainty as to what sort of event may be possible, if any, it was decided that the risks and anticipated limitations of having the event compelled the action being taken.

This decision was made in consultation with and the concurrence of John Sutton, PDDGER and Chair of the Mid-Term Planning Committee, and our Past Association Presidents, and we thank them for their counsel and shared concern.

We express our deep appreciation for the many efforts of John Sutton and his committee who worked for many months planning the event; we are very sorry that the fruits of their labors could not have been realized.

Nevertheless, the work of our Association must go on, and the decision has also been made that a series of Zoom meetings will be scheduled for the Association's various leadership bodies. Anyone with any questions is encouraged to contact our Executive Director Tim Martin at the CHEA office. The Zoom meetings are tentatively being planned for the time-frame during which the conference was to be held, November 6-7, 2020, but further information will be forthcoming.

This action is being taken for what is believed to be the best interests of the members of the California-Hawaii Elks Association, and your understanding will be appreciated.

Wow the months are just flying by. I hope this article finds you and your families all safe.

There are many new changes this year for ENF in many areas.

ENF 2020-2021 per Capita

During last weekend's call with our new GER Paul Ryan, Jr., he announced that our per capita would be raised to \$4.80. Last year our Lodges nationwide raised \$6,697,176.55 for the ENF setting an all-time high. Through July 28, 2020 CHEA Lodges are currently at \$263,068.33 or \$2.986 per capita.

There are a few changes coming next year for the Donor Recognition program as well. There will be a discontinuation of the three cumulative recognition levels below the \$1,000 level. The Participating Member (\$100), Sustaining Member (\$250), and the Distinguished Member (\$500) will all end on March 31, 2021. If you are working towards these levels, please get your donations in early.

What if you could donate without having to think about it? Well, you can. Enroll today and become a member of the Fidelity Clubthe ENF's monthly giving program.

Why Join the Fidelity Club? The ENF Fidelity Club recognizes automatic, regularly scheduled donations through your bank account or credit card. These donations can occur monthly (minimum \$5) or quarterly (minimum \$15). It saves a tree and time with paperless donations. There is no need to mail in your donation. You can increase, modify or cancel your gift at any time. It's safe, reliable and allows the ENF to spend less time on administration and more time on our charitable mission. You can enroll online at enf.elks.org/recurring and start your gift today!

Community Impact Program (CIP) or Lodge Grants

By now you are aware that the starting dates for many of our Grants changed and there are a few Grants not being offered this

Impact Grant - postponed (see below) **Promise Grant** – postponed (see below)

Beacon Grant

On August 1, Beacon Grants will become available to every Lodge in the amount of \$3,500—a 40 percent increase over last year's grant amount.

Typically, Beacon Grants must be used for active projects. But, since nothing is what it was, we've built in flexibility for Lodges to meet pressing needs in their own backyards. Here's how we are relaxing Beacon Grant guidelines.

Keep on keepin' on. If the Lodge can continue its regular Beacon Grant project with safety precautions, fantastic.

Nope, not safe. If an active Elks-led project isn't feasible, donations will be considered to the partner organization the Lodge usually works with, or to an organization providing COVID relief.

hange it up. If a Lodge would like to pause its regular Beacon Grant project to do a COVID-19 relief project, we're all for it.

Split it up. From the beginning, the Beacon Grant has only been allowed for one annual project. This year, it can be split between

up to two projects.

Merge it. With just the click of a button on the Grants Dashboard, the Lodge can opt to merge their Spotlight Grant with their Beacon Grant, making a total of \$5,500 available for a Beacon Grant project.

We announced way back in the pre-pandemic days of late February that the Beacon Grants were set to be \$3,000 for FY2021. However, by suspending both Promise Grants and new Impact Grants, we can offer Beacon Grants at \$3,500. With the increased grant amount and built-in flexibility, we're confident that Lodges will continue to rise to the occasion and help communities where it's needed most.

Promise Grants

In normal times, Promise Grants are awarded on a first-come, first-served basis to the most qualified projects. For FY2021, we budgeted \$750,000 to fund 300 Promise Grants. Instead, we reallocated the funds for Promise Grants to Beacon Grants. Here's why.

In a typical year, Promise Grants must be used for active projects; however, in many parts of the country, active projects are not feasible. That's why we relaxed the Spotlight Grant guidelines to permit passive projects (donations) and encouraged Lodges to donate their Gratitude Grants.

The relaxed approach works for Spotlight Grants, because every Lodge is eligible to use one, and for Gratitude Grants, because every Lodge that met the GER's goal last year is eligible to use one. But there are only 300 Promise Grants. Relaxing the Promise Grant guidelines would have kicked off a frantic cash grab.

This decision means that some Lodges will receive less money in CIP grants this year than they did last year. That's unfortunate; however, there's no way that we could justify giving \$750,000 to 300 Lodges based solely on which Lodges had the fastest typists.

Impact Grants

We applied the same logic to consideration of new Impact Grants during the time of COVID-19. We think of Impact Grants in terms of new and renewals. New Impact Grants are projects we are not currently funding; renewals are the ones we are currently funding.

The budget the Board approved in February contained \$200,000 for new Impact Grants and \$300,000 for renewals. For FY2021, we will not be accepting applications for new projects. Instead, we are reallocating the \$200,000 budgeted for new Impact Grants to Beacon Grants.

We are in the throes of reviewing the 64 - 2020 Impact Grantees' Second Quarter reports. The decision to move forward with the renewals will be announced on **September 1**.

2020 MVS Scholarship • 1st Place Winning Male \$50,000 Scholarship • Montebello Lodge 2051

Santiago Alvillar, a graduate of South El Monte High School, is the recipient of a \$50,000 scholarship from the Elks National Foundation.

It wasn't until his school recognized him as a gifted student that he began to develop his passions as a Science, Technology, Engineering, Mathematics (STEM) student.




School became a coping mechanism for him — a way to escape the harsh realities of his world. In high school, he was president of clubs like the Emerald Jewel (an environmental club), the California Scholarship Federation as well as Program Director of the Freshman Mentoring Program. His other activities included juggling, Cross Country and Track and Field. He also received scholarships to attend prestigious engineering summer programs at Stanford, Yale and Princeton in his Sophomore and Junior years.

This year, Santiago graduated as Valedictorian from South El Monte High School and received admission from Stanford, Harvard and MIT.

He plans to complete his undergraduate degree at Stanford University, majoring in Engineering Physics with a specialty in Energy Alternatives.

He hopes to complete his Masters and Ph.D. for Environmental Engineering in the near future to continue his work on creating safe and efficient energy alternatives for everyday consumption.

Membership Retention and Lapsation

Congratulations! Once again CHEA had the largest membership increase in the nation. We grew by 1320 new members over the previous year. That's remarkable given the abrupt way our year ended. Once again, we have shown our Association to be the flagship of the Order. We exhibited that we're able to use what we've learned to grow the program year after year.

However, this year we have a bit more of an obstruction on the road to success.

The coronavirus has presented us with an epic challenge. The uncertainty it brings is jarring enough to upset most of what we would normally plan. But the ancillary issues such as social distancing, the recommendation that you limit your person to person contacts to your immediate family and remain at home as much as possible. When we add to that the fact that, most if not all of, our Lodges are closed with no reopen date, the social side of the Order is quashed. How do we keep things together? We innovate!

We cannot allow this pandemic to weaken our Order or financially drain our Lodges. Through this dark time, we need to keep our members involved. Even if the Lodge is closed, we have to keep it alive and let the membership feel they're still a part of it. And a shuttered Lodge still generates costs we'll need to cover.


What can we do? The methods and means of keeping the heart of Elkdom alive is limited only by your imagination and willingness to work at it. Some of the events that are or have been held in my small District are drive-thru dinners, where members order ahead off a pre-determined menu and at the appointed time drive to the Lodge to collect their food. The food is generally passed out in the parking lot or passed through a door of the Lodge. We've had Virtual Fundraisers conducted over Zoom, regular "Patio Dinner Nites" in compliance with State and Local regulations. This is the tip of the iceberg, I'm sure if you give it a little effort you can find suitable, compliant events to involve your members and keep them active, even if it's virtually.

Another aspect of that bump in the road I spoke about is Delinquent Members. Because of the unforeseen halt to the last year I believe we missed some opportunities that have come back to haunt us this year. People quit paying dues, many may be confused as to where or how to pay, some may feel that because the Lodge is closed there is no need to remit. Every single Lodge, regardless of the level of services you're able to offer at this time, should be sending out dues notices every month. There are currently 14,834 delinquents as of August 1, 2020. This is easily 5,000 more than last year at this point. It's a huge number that represents almost 17% of our total membership. In addition to monthly mailings Lodges should have a program set up to call everyone on that list to check their well-being, see if they need any help from the Lodge, a ride to the doctor, getting groceries, help paying their dues. Every Lodge has a Standing Relief Committee, now's the time to put them to work.

The flip side of Delinquency is Initiation, how do we do that in this time of Pandemic? Inductions into the Order have been conducted by Zoom, in the Lodge Room with masks and social distancing, outside the Lodge in a patio or other appropriate place. Although our Lodges may be closed as far as meetings and events are concerned, we are not moribund. We need to continue to mail out monthly late notices, lodge newsletters and do what we must to stay in contact with the membership. The Benevolent and Protective Order of Elks is not some remote entity encased in a marble temple in Chicago. The BPOE is you and I and all those intertwined in this great family of patriots, philanthropists and upright citizens drawn from the multi-cultural and diverse population of our beloved America.

As the Elks have, since their inception, we will survive this plague as we have natural disasters, financial collapse, wars and social upheaval. How well we pass through this depends on how much we are willing to give in time and effort to keep it vital and relevant. There may well be a long road to the end of the active age of this pandemic. And when we see the light at the end of the tunnel it will surely shine on a world reordered in many ways by the Virus we fight today. Our strength and vitality at that point will depend on your grit and perseverance from this point forward.

Santa Monica Lodge 906 has helped the veterans in their community with the following grants this year:

FREEDOM GRANT

Operation Veteran Support (OVS) is designed to assist veterans to reintegrate back into civilian life. This program involves veterans from the WLA VA Hospital and Step Up on Second Shelter with clothing, shelter, and hunger issues. This grant will expand the current reach of the Elks into our community by dealing with a large homeless veteran population in the Santa Monica area.

FOCUS GRANT & IMPACT GRANT

The Lodge will be giving "Welcome Home" baskets, blankets and major household items, mini-freezers, mini-refrigerators, kitchenware, etc., to veterans that were homeless and are now housed in permanent housing.

Santa Monica Elks have teamed up with new building structures in the South Bay community to disperse these items. Along with Grand Lodge's commitment to helping the VA with the homeless population and VA strength, the Elks of 906 have committed themselves to help supply items needed by Veterans and to end homelessness. The Elks determined the need for this Veteran homeless program by researching the databases with the City of Santa Monica, West Los Angeles Veterans Administration, Veteran Affairs Supportive Housing (VASH), and Step Up on Second.

West Covina Lodge 1996 has helped the veterans in their community with the following grants this year:

FREEDOM GRANT

The West Covina Lodge 1996 has donated the entire Freedom Grant's \$2,500 to the Long Beach VA's Women's Closet. The Closet gifts much needed clean, new clothing items and shoes, including job interview appropriate wardrobe items, to homeless female veterans and female veterans existing at or below the poverty level. The availability of such items eliminates the Long Beach VA's need to refer to this vulnerable yet important popu-

lation to outside agencies, which might not have the same concerns or goals in serving female veterans. It is anticipated that the Closet will serve as the female veterans' introduction to the invaluable services provided by the VA, including behavioral health services.

FOCUS GRANT

The West Covina Lodge 1996 was awarded the Focus Grant for "Operation Healthy Choices, Healthier Veterans." West Covina, in partnership with Duarte Lodge 1427, will conduct two free food distribution events in a farmers market-style environment, at New Directions for Veterans' Baldwin Rose, El Monte Veterans Village, and Palo Verde permanent supportive housing facilities. "market" will offer pantry items, fresh meats, dairy, produce, home-baked treats, and household cleaning supplies to the 83 previously homeless veterans and their families now housed at these facilities. To take advantage of the amazing seasonal produce available in Southern California, each facility will experience one distribution in late summer 2020 and the second in early winter 2021.

BEACON GRANT

The West Covina Lodge 1996 intends on submitting its Beacon Grant application to continue its highly popular Welcome Home Baskets Program. In partnership with organizations coordinating the housing of previously homeless veterans, West Covina Lodge members collect and distribute household items such as linens, and pots and pans. The West Covina Lodge believes these gifted items convey the feelings of warmth and security a new home can bring, as well as assist in the veteran's transition to permanent supportive housing.

I want to remind you about veteran suicide rates, which are currently at 20 a day. I can't stress enough the need for our Lodges to get involved in our veterans' community. There are many ways to get involved and help our veterans today:

- Contact your county Veterans Service Officer.
- Look into your local Stand Down.
- Contact your local VA hospital and speak with someone from their social services program.
- Forge partnerships with the American Legion, VFW, and other veteran organizations

In closing, We have great opportunities to help our veterans in our communities. I would like to see a new program introduced in each CHEA Lodge over the next year. I ask that you stay safe and keep in mind the safety of others. I look forward to reading about your events that are in your Veteran's Lodge reports. Please, if there is any way I can help contact me.

BLT Legacy Giving

I sincerely hope you are doing well as we continue to adjust our lives to survive this pandemic. It has been an interesting time and I am sure Barbara joins me in saying that we have missed seeing all our Elk friends in person whether at conventions, Lodge meetings or other Elk events.

I want to tell you a little about the BLT Legacy Giving program. This program was envisioned in 1981, and started accepting donations in 1984. Its main purpose is to help Elk members provide funds for future generations of children who might need our therapists' services. Leonard A. Cosgrove created the name BLT in 1986, a takeoff on the bacon, lettuce and tomato sandwich, or BLT. The tie-in of the Purple Piggy Bank made it a natural fit.

Some ways you can make a gift through the BLT program are in your will or trust, or by designating California-Hawaii Elks Major Project (CHEMPI) as a beneficiary of a bank account or insurance policy. A member who makes a gift to the Major Project (through the BLT program), can be recognized during their lifetime under the Benefactor program, or they can donate anonymously. If you want to document your gift and receive recognition, just send a signed and dated statement to the CHEA office in Fresno indicating that you have made a gift to the Major Project through the BLT program. You will receive a letter asking you to complete a release form. After you return the completed form to the Fresno office, your name will be placed on the BLT master list, and you will receive a Benefactor's Certificate and a distinctive triangular BLT lapel pin. You should wear that pin with pride.

What kinds of gifts can you make through the Benefactor Program? Individuals can designate gifts of cash, stocks and/or real property, or they can designate the Major Project as a beneficiary on a Life Insurance policy. Here is sample language you can provide to your attorney or financial advisor. I give the sum of \$____ or ___% or I give the following property to the California-Hawaii Elks Major Project, Inc., 5450 East Lamona Avenue, Fresno, CA 93727-2224 (tax id: 95-1919366) to be used or disposed of as its Board of Trustees deems appropriate in its sole discretion.

Remember, if you want to be recognized for your generosity to the Major Project, just let us know and we can make it happen! Stay safe and Barbara and I hope to see you soon.

The State of California was briefly reopened, then promptly shut again. Many counties are allowed to operate business outside only. If this is something your Lodge is considering, it must be ensured that all County, State, and Federal guidelines are followed. Any applicable county health permits must be obtained. Additionally, if the ABC license held by the Lodge is not zoned for the outside area, the Lodge would need to contact ABC for the proper use license to serve outside. If a Lodge has followed all required laws, then the Master Liability will cover the outside service.

It has come to our attention that State Compensation Insurance Fund is offering grant money to businesses for safety necessities to become Covid compliant. This would only be for Lodges that carry their workers' compensation insurance through State Fund. Although I am not aware of any other carrier offering this, it certainly wouldn't hurt to ask whatever company holds your Lodge's Worker's Compensation Insurance.

I have faith we Elks are all still making an impact in our community. Elks persevere, and better times are coming. Stay safe and healthy!

The CHEA Drug Awareness website is now up to date with all the material needed for the Drug Awareness Program Essay, Poster and Video contests for 2020-2021. This year's theme for the contests is "DRUG ABUSE?, NO EXCUSE!"

Essay Contest: All students in the 6th, 7th, and 8th grades are eligible to participate. Students must write the essay themselves, but they may get help from teachers, parents or friends in the form of ideas.

Essays are to be 250 words or less and typed, computer generated text, hand-written or hand printed on 8 ½ by 11-inch paper.

Each Lodge submits the 3 top essays to the District Chairman, based on the dates established by the District Chairman.

The District Chairman submits one essay to the CHEA DAP (Drug Awareness Program) Chairman as the first-place winner for their District.

Essays must be received by the CHEA DAP Chairman, from the District Chairman no later than January 15, 2021. All Essays become the sole property of the Benevolent and Protective Order of Elks and will not be returned.

Judging will be based on the following:

A. Is the essay based on the theme?

B. Is it original?

C. Is it neat?

D. Is it grammatically correct and are words spelled correctly?

Each State Chairman will choose one overall winner. This winning essay will be submitted for entry into the National Contest.

Poster Contest: All students 3rd to 5th grades are eligible to participate. Poster size should be limited to 8 ½ by 11 inches Posters should be neat, original, grammatically correct and words spelled correctly. Judging will be based on closeness to the theme. The use of copyrighted characters on the poster, other than Elroy The Elk, will be disqualified.

All winning posters become the property of The Benevolent and Protective Order of Elks and will not be returned. Each Lodge submits the top three posters to the District Chairperson, who, in turn, selects the top poster from the District and submits it to the State Chairman. ONLY original posters will be judged. No copies. How Posters are judged:

A. Is poster based on the theme?

B. Is it original?

C. Is it neat?

D. Is it grammatically correct and words spelled correctly?

E. Is it free of copyrighted characters, with the exception of Elroy the Elk?

Each State Chairman selects one overall winner. This winner is submitted for entry into the National Contest.

Video Contest: The contest is open to three age groups: Pre-High School, High School and Postgraduate. Participants may be an individual or work with a group.

Videos should be 2 to 5 minutes in length and submitted on a Flash Drive ONLY. Videos should have an anti-abuse message or making the right choice message. Videos should not depict any copyrighted characters or Trademarks with the exception of Elroy The Elk.

All entries become the sole property of The Benevolent and Protective Order of Elks and will not be returned. Judging will be based on the following:

A. Closeness to the theme

B. Neatness

C. Originality

D. Age and language appropriate

E. Positive message

F. Quality of video

Each Lodge submits one video to the District Chairperson. The District Chairperson will select one video in each of the three groups to submit to the CHEA DAP Chairman.

Each State Chairman will choose one winner from each of the three groups to submit for entry into the National Contest. Applications and more information are available on the CHEA Drug Awareness website.

In other news, Westchester used a Spotlight Grant to buy "Welcome Home" baskets for Veterans moving from transitional housing to permanent housing thanks to Grant Chair, Fiona Engler and Veterans Chair, Dale Thompson. The \$2,000 grant helped to purchase bedding, dishes, towels, and other essentials one would need to start in a new home.



Santa Maria Lodge 1538 distributes 12-16 Tons of food through the Food Bank of Santa Barbara County every week. Since mid-March it became obvious that there was a major need to provide food for the community, as businesses shut down and people were out of work. Exalted Ruler Wes Brown was contacted by the Food Bank to see if the Elks Lodge would be willing to provide a place for a distribution Center. Not only did the Exalted Ruler say yes, but he offered the Food Bank the Volunteers to staff the Center. The Volunteers are primarily made up of Officers and wives, but soon many Lodge members and people from the community, came out weekly to help. The Thursday Distribution Center has quickly become one of the largest in the Santa Maria Valley with people lining up in their cars two wide winding throughout our large parking lot and down the street waiting up to an hour just to make it to the front of the line.

Since beginning this endeavor, the Lodge has helped over 5,642 families, handing out over 10,884 bags of food. The volunteers begin at 7:00 am, unload sometimes up to three truckloads of fruits, vegetables, canned goods, drinks, cheese, bacon and more. Since late March, based on the invoices of the truckloads, we have averaged 12 to 16 tons of food distributed weekly. It is a lot of work, but also extremely rewarding. The Officers and Volunteers could not be happier to provide this much needed service to our community.

Santa Clarita Lodge 2379 received four ENF Grants, totaling \$9,000. The \$2,500 Beacon Grant was used to purchase household items for a veteran family, that was gifted a home from The Santa Clarita Veteran's Collaborative. The Lodge shopped with the family, to find a new oven for the home. as well as, helping to furnish both inside and outside of their home.

With the \$2,000 Spotlight Grant the Lodge worked with one of our Lodge members who works very closely with disabled veterans. The Lodge purchased \$50 Walmart Gift Cards. Member, RJ Kelly, researched families and distributed the cards to Veteran's in need.

The \$2,500 Gratitude Grant, was used to help out our local Child and Family Center. Due to COVID-19, they lost their largest fundraiser of the year, our timing was perfect to help them with a check as they had just started a program called Hearts for Heroes Giving Wall.

The final \$2,000 grant was used to support local senior center, Bella Vida, which is supporting so many homebound seniors with food, due to COVID-19. They are in desperate need for food they can distribute to the seniors. The Lodge is holding an ongoing food drive for them and used the \$2,000 to purchase additional food.

Fullerton Lodge 1993 continues to support Military Showers of Support. Expectant families at Camp Pendleton are able to receive free baby items, clothing, diapers, strollers, etc., coordinated by Deployment Readiness Coordinators. Regular donations of cash and baby items are made by Lodge members and can include hand made baby blankets, diaper covers and toys. A \$500 donation was made to the San Diego USO to assist the crew members of the USS Bonhomme Richard. Many lost all of their personal belongings in the fire. Men's hygiene items, such as t-shirts and socks were donated to the Long Beach VA, at their request recently.



Santa Maria Lodge 1538 used the Spotlight Grant to donate \$2,000 to the Good Samaritan Shelter in Santa Maria. The Good Samaritan Shelter has struggled during this COVID-19 Pandemic to continue to provide the services, such as helping the homeless and those needing drug and alcohol treatment in the Santa Maria Valley. In addition, they opened an emergency shelter for vulnerable adults providing staffing and three meals a day. They placed eighteen Veteran households into temporary housing with local hotels and providing three meals a day.

During the Grab n' Go dinners, the Lodge was able to raise \$500 which it presented to CASA (Court Appointed Special Advocates for Children). The Lodge chose to direct this donation to the "Shelter House" which helps with Illegal Trafficking of Adults and Children.

In other news, the Lodge, in order to maintain our facility and keep as many of our employees employed, it became necessary to serve a Monday and Friday curbside meals to both members and the community. At first it was overwhelming to serve the hundreds of people that responded to support us, but with each week the Lodge perfected our system and have now sold over 12,539 meals since late March. On Mother's Day, the Lodge served 1,000 meals and are now averaging 300-650 meals every Monday and Friday.

Many nights meals are leftover, so the Lodge calls the Santa Maria Police, Highway Patrol and City Rangers, in addition, we have donated many meals to the nurses at our local Hospital. To date Santa Maria Lodge has donated at least 1,205 meals to our community first responders.



Petaluma Lodge 901 received a \$2,000 grant for the Technology Student Association (TSA) community support programs. They received and donated the grant to TSA to help families impacted with COVID-19. "This infusion of funds could not have come at a better time", said TSA Corps Officer Mitham Clement. In other news, the Lodge was asked by Ventura County Health Department to provide the use of the parking lot for a free Covid-19 antibody testing site for the community. In the first eight hours, more than 500 residents were tested.

Chula Vista Lodge 2011, in December 2020, will be hosting the 4th Annual Veterans Families in Need Christmas Party through the use of the Freedom Grant. The Lodge, working with Us4Warriors. will be providing a Christmas extravaganza for 22 active duty military families in need of extra support during the holidays. The Lodge works with the local military base social workers and commanders who select these families based on their ongoing and unremitting personal needs. Many of these families have special needs children which prevents both parents from working, some have deployed spouses, some have been wounded in action, and all are making monthly decisions on how to feed their families and pay their bills.

Palo Alto Lodge 1471, Reeves family was passionate about Elks's mission, including the CHEA Major Project, which provides therapy for physically challenged children. The family gave a sizable donation to our Lodge to provide scholarships for students who are enrolled in a Physical Therapy Program working towards their Masters or Doctorate in California.

This year we had 16 applicants apply for the scholarship, a record number with applications coming from 5 schools within California that included: Azusa Pacific University, UC Long Beach, UCSF, Mount Saint Mary's University and Samuel Merritt University.
