Honolulu Lodge 616 started an Adopt-a-School program in 2020 with Kalihi Waena Elementary School, a school that serves a population of many homeless and poverty level students. The Lodge embraced the principal's "pie in the sky" project of a pergola covered walkway. Lodge members stepped forward to supply the lumber for the pergola, cement for the walkway and the Masons union laid the concrete at no charge. The school maintenance staff, along with the principal built the pergola, the students planted and cared for the donated citrus trees - all based on our kick-start commitment to the project. During 2021-22, Halau Ku Mana, a Hawaiian charter school, was adopted, school supplies and backpacks for all 521 students, and sports equipment, to establish athletic programs at the school.

The Elks National Foundation truly defines who and what we represent in our communities. If you've ever had the opportunity to explain to someone who and what are the Elks, consider describing ENF. In fact, talking about ENF is the perfect elevator pitch about why being a member is so impactful. Your pitch might sound something like this...

Elks are American citizens who proudly serve their communities by supporting veterans and active-duty personnel programsand programs addressing hunger, as well as youth and senior needs. It's the largest drug awareness organization in the country and the leading contributor of scholarships to graduating high-school seniors. Our National Foundation gave approximately \$41 million back to our community, not including what we give back on a local or state level.

What we accomplish as Elks was well stated at Grand Lodge this year in Atlanta, Georgia. The impact of our programs was demonstrated through the presentations of the Most Valuable Scholar winners, the Drug Awareness Programs, Veteran Programs, and the 50th Anniversary of the Hoop Shoot.

Our CHEA membership continues to exemplify the message of giving back to our communities. At just 4 months into our new year, and as of today's writing, our ENF donations have surpassed last year's donations. As of today, ENF has received \$345,874 in donations. This is an outstanding effort by our CHEA Lodges! There are, however, several Lodges who have not yet contributed any funds to the ENF. We encourage all Lodges to continue to rally members to help reach our GER's goal of \$4.80 per member. Let's also challenge ourselves to surpass last year's average per capita of more than \$10. We know our CHEA Elks can surpass that amount this year.

It's easy to make a difference. Here are four ways you, our Elk families and friends, can give money to the Elks National Foundation:

- 1. Become a recurring donor through the Fidelity Club. With as little as \$5 a month, you can make automatic, regularly scheduled donations through your bank account or credit card via: ENF.elks.org/reoccurring;
- 2. Consider naming ENF as your matching charity through work sponsored donations;
- 3. Make a one-time donation to the Foundation by check or cash to your Lodge, or online at the ENF website: ENF. elks.org/Mylodge;
- 4. Participate and bring a friend to your Lodge's next ENF fundraiser event. Remember, October is ENF fund raising month.

Also, all district as the ENF chairpersons, you are required to register each year as ENF the chairperson for your district and/ or Lodge. Registration is important for our Chicago ENF office to know who you are so they can send you vital updates and information about the Foundation. Welcome Home Kits are a great way to support Veterans moving into a new home after a period of homelessness. More information can be found at www.elks.org/sharedelksorg /vets/WelcomeHomeKitFAQs2021-22.pdf

Here are some of the guidelines:

- How much are Welcome Home Kits worth? The ENVSC will reimburse up to \$300 per kit, and up to \$500 per kit if that kit includes a bed.
- So, I can buy a \$500 bed and call it a kit? Not guite. A kit should always include a variety of household supplies. We ask that Lodges do their best to find deals and discounts. We recommend that beds not comprise more than \$400 of a single kit.
- If we are able to provide a bed for free, can we spend the full \$500 on other household items? Unfortunately, no. The additional \$200 for kits with beds is intended to provide beds for veterans who otherwise would not be able to afford them. The maximum amount of reimbursement per kit for non-bed items is \$300.
- Do the items have to be new? Can used items be used? Kits can be comprised of new and/or used items. Lowcost retailers such as Walmart, Target and Dollar Tree are a great way to stretch your dollar on new items. Don't forget about consignment and thrift stores for furniture and other items.
- How do I find veterans who need these supplies? We encourage your Lodge to partner with the VA or another veteran's organization on this project. Start by contacting a local VA facility and ask about their HUD-VASH depart-

ment. Or connect with a local veterans transitional facility or homeless shelter.

In closing, Vice Chair John Hardman and I commend each of you for all you do to help Veterans. Keep up the good work! The California-Hawaii Elks Association leaped to number one in the Country in Charitable Donations. Last year our donations totaled over \$64,000,000. increasing contributions

by \$48,000,000. We are the Champions!

During Grand Lodge, our National Committee met to discuss missed opportunities and new ideas that all Lodges could take part in. Our focus was contrary to the prevailing status quo, we agreed there were better ways of doing things. We have established new recognition award for Lodges who increased donations by 10% or more, in addition to State Chairmen who achieve 100% in reporting.

It has been determined that, on average, most Lodges have only been reporting a small percentage of their charitable data. Using the calendar from your monthly newsletter should always be the guide to completing your report. We established a new monthly Government Relations report which ask specific questions reminding Lodge Chairmen there is more work that needs to be done, like improving your relationship with your local Government. It's a lot of work, this Lodge Committee cannot be run by one person. Every Lodge Chairman should be entering your monthly contributions into CLMS themselves; your Lodge Secretary has the discretion to make this available to you. This will save your Lodge Secretary valuable time and energy and the Chairman will have a better idea of his or her job. Every Lodge Chairman should be sending the last 3-year totals to their local Government, easily found on Elks.org. Every Mayor, Council Member and County Supervisor needs to know how much your Lodge has contributed. Your report should Include all of the Grant and Scholarship opportunities that ENF has to offer, they will love it.

Your leadership is teaming up, combining forces with State Chairpersons Tom Lemm, David Coleman and myself to forge through this upcoming year. Between the 3 of us we have you covered. Now be successful and at the same time preserve our Tax Status. I will see you at Mid Term Conference in Burbank!

Vocational Grants: CHEA's Best Kept Secret

The California-Hawaii Elks Association website provides most of the information you need to apply for the grant. What it doesn't tell you is who and how this grant helps people in our communities. In the last year we have awarded 25 grants ranging from \$1,200 to \$2,000.

The first grant went to a lady in rural California, who had just sent her youngest child off to the Marine Corp and would now have the time to work on her future. She was working parttime for a veterinarian and wanted to take a Veterinarian Technician training course, which upon completion would allow her to work full-time for a lot more money.

Another grant went to a young man who told me that he had gone to junior college for a couple of years, worked in construction, and then COVID hit and everything kind of fell apart. He asked for a grant to attend a vocational training program to become an electrician. Grants were also awarded to people wanting to work in esthetician and cosmology fields, to people who were studying aircraft maintenance and avionics, and to people wanting to earn a medical certification.

The only thing that these award recipients have in common is none of them is a recent high school graduate. They have all been out living and working in the real world and have found a program, that with our help, will allow them to build a better future for themselves and their families. The Vocational Grant is open to male and female applicants who will be judged on an equal basis. While graduating high school seniors may apply, it is not limited to high school students-in fact, it is open to all prospective students who require training or retraining to compete in the workplace.

The Vocational Grant is open to anyone residing in California or Hawaii, who is a citizen of the United States of America and planning to pursue an eligible vocational/technical (voc/tech) course resulting in a certificate or two-year degree and leading to employment opportunities. The Grant is for one academic year, with an option to renew for one additional academic year. Awards will be between \$500 and \$2,000 for an academic year depending on length of course. Students planning to transfer to a four-year school to pursue a bachelor's degree are not eligible to apply.

Now that the secret is out, spread the word! Applications and more information on the Vocational Grant and the Undergraduate Scholarship for Students with Disabilities can be found on the California-Hawaii Elks Association website under scholarship or contact your Lodge Scholarship Chairman.

The ELKS Most Valuable Student Scholarship program opened August 1, 2022. Information can be found on elks.org. You do not have to be an Elk to apply, but the application is completed online. The information for the Legacy Award Scholarships for children and grandchildren on Elks, can also be found on the elks.org website.

Greetings Members:

Many of you have asked about the workings of the Commitment Trust. As you know, a Commitment Trust is established by the

donation of Ten Thousand Dollars or more to establish each separate Trust. Each Trust is a separate entity which continues for your lifetime and the lifetime of your spouse. Each Trust pays a 7% return on the donation. OK, Barbara, we know that...but how does is work? The Commitment Trust donation can be made in one name, or in both you and your spouse's name. You will get a partial income tax deduction for the donation, the amount will be figured for you. Why only a partial deduction? Because you will be getting benefits from the Trust during your lifetime. The Trust will pay these benefits so long as either you or your spouse is alive. Once both have passed, the remainder of the Trust will be given to the California-Hawaii Elks Association Major Project, Inc....and will then benefit the children that we assist throughout California and Hawaii.

During your lifetime, you can add to the Trust. As you get older your partial income tax deduction for the gift will be larger, but again only a partial deduction due to the benefits to be received. I know that you wonder if the 7% return that you get is tax free. Unfortunately, no...the payment is made up from interest and dividends from the investments in the Trust. You will receive a K-1 annually letting you know what you need to claim. The investments for ongoing Commitment Trusts have been doing well over the years, so it is likely that all of the return is taxable. But remember that keeping the return high is what insures that a majority, if not all, of your donation is preserved for the Major Project.

How do I start? You start by contacting the CHEA office who will then send you forward to the appropriate person. You will be asked for your birthdates(s) and full legal names. The tax deduction will then be calculated, and a Trust document will be prepared for your review. These types of trusts (Charitable Remainder Unitrusts) are established to conform with IRS Guidelines, so it's important that a formal agreement be prepared by an experienced person.

It would be remiss of me to not mention that you can establish a charitable gift to the Major Project within your existing estate plan, or even set up a Charitable Trust on your own. But establishing a Commitment Trust through CHEA eliminates the cost. If you have any questions, you can contact me, my contact information is on the CHEA website.

So much has happened in the world of the Elks Drug Awareness Program this past month. As CHEA DAP Chairman, it was my honor to represent our Association at the

2-day National Training provided to State Chairmen from throughout the United States. This training was a prequel to the actual Grand Lodge Sessions in Atlanta, GA. The training was a "return to basics" to assist New and returning Chairmen of the various components of the DAP programs. Also announced at the training, California Hawaii Elks Association once again had a National 1st place Winner in the DAP Video Contest. Samantha L., a seventh grader from De Portola Middle School in San Diego, was chosen to receive this honor. This video was submitted by the South Coast District Chairman, Patty Hamilton, Kathleen Kuttler, Lodge DAP Chairman, and San Diego Lodge 168.

Of note at the National Convention in Atlanta was the passing of Resolution 4. The purpose of this resolution was to create, establish, and codify a new National Drug Awareness Commission, to better support and promote the Order's programs designed to increase drug awareness and address the dangers surrounding substance abuse thereby keeping communities across the United States informed about the risks and dangers. In other words, our Elks Drug Awareness Program is now recognized by statute. This resolution passed by a resounding 2,463 yes votes to 221 no. Let's take this resolution and make a firm effort to promote this program in our Districts and Lodges.

Drug Awareness Contests for 2022-2023: The theme for the 2022-2023 Elks year poster, essay and video contests is "One Pill Can Kill". All information related to these contests, including rules and entry forms, has been updated on the chea-elk.org website. Your District Drug Awareness Program Chairman will set the date when each of the contests are due to him/her. Your Lodge contests should be completed prior to that date. The District Chairman will then judge the entries and send the winning entry in each contest to the CHEA Drug Awareness Program Chairman.

Enrique S. Camarena Nominations: Each year, the Elks, through the Drug Awareness Program, searches for members of the law enforcement community who best exemplify the qualities and principles for which Agent Camarena gave his life. Nominees should be involved in their communities in an effort to help that community become drug-free. Nominees must have the support of their Agency and the respect of their communities. If you know someone who qualifies for this nomination process, please contact your Lodge and/or District DAP Chairman for the nomination forms. All nominations are due to your District Chairmen prior to October 1, 2022.

DEA Scout Patch Program: The DEA Scout Patch Program is open to boy and girl scout troops nationwide. This program is designed to provide scouts with the opportunity to earn a patch from the Drug Enforcement Administration (DEA) by

engaging in anti-drug activities in celebration of Red Ribbon Week. The dates of the program are July 1st through November 30th. For more information, go to the website: www. getsmartaboutdrugs.gov/get-involved/red-ribbon-week-patch-program.

Red Ribbon Week: This October marks the second annual National Substance Abuse Prevention Month – an observance to highlight the vital role of substance abuse prevention in both individual and community health and to remember those who have lost their lives to substance abuse. Red Ribbon Week, October 23-31st, is a vital part of this month. Red Ribbon Week is an alcohol, tobacco and other drug and violence prevention awareness campaign observed annually in October in the United States. It began as a tribute to fallen DEA special agent, Enrique S. Camarena in 1985. Red Ribbon Week is the nation's largest and longest-running drug awareness and prevention program. It's never too early to plan your Lodge's Red Ribbon Celebration for the month of October. There are many ways to celebrate Red Ribbon Week and every part of your Lodge and community can get involved.



Fullerton Elks 1993 hosted a drug awareness booth at the Good Life Celebration, an event at the Gomez Community Center in Placentia. Sponsored by Lot 318, a non-profit that exists to walk alongside at-risk youth and their community by empowering them to see their worth and purpose in this world. 
