As we close out our year, and on behalf of the CHEA ENF Chairpersons, Kealoha Arelliano, and I want to express our appreciation to all our district and lodge ENF fundraising chairpersons for the great work they accomplished during the last Elk year. The ENF Community Investment Program awarded 164 Lodges in CHEA a total of \$1,131,500 in grants this past year. Lakeport Lodge 2704 applied for and received three ENF Grants, totaling \$11,500 for our Community. The \$3,500 Gratitude Grant will help Operation Tango, sending monthly care packages to deployed troops. The \$4,000 Beacon Grant will allow Lake Family Resource Center to provide a variety of services in guidance, family development, and to maintain its family safe shelters. The \$4,000 Spotlight Grant will allow Upper Lake Senior Center to upgrade its community kitchen to help provide for the community's food needs.

Napa Lodge 832 received a \$4,000 Beacon Grant, which will be used to support the ongoing operation of Canine Companions Headquarters, and Northwest Training Center in Santa Rosa. A Spotlight Grant of \$2,000 was also awarded to Canine Companions for necessary supplies to support the operation.

Petaluma Lodge 901, used a Spotlight Grant by donating \$2,000 to the Sonoma Family Meal to support their Hunger Relief program. The impact that Sonoma Family Meal has on our community is truly commendable, the Elks are honored to contribute to their efforts. We believe in the importance of coming together to support those in need, and their organization exemplifies this spirit.

Monterey Lodge 1285, donated a \$3,500 Elks Beacon Grant to the Point Lobos Foundation (PLF). The funds will be used to support the PLF's school walks, a program to educate, and inspire children to preserve Point Lobos State Natural Reserve's resources.

Rudy Augustus was born at 9:59 in the evening on March 2nd, 2023. Due to his positive prenatal screening for Down syndrome, his family knew that his birth story may be a challenging one. Family back in Wyoming were standing at the ready to help as his planned homebirth began, in case support was needed with Rudy's early care. Rudy's midwife suggested transferring to the hospital, when he was not tolerating contractions well. Despite a vigorous first appearance following a natural birth, Rudy went into respiratory failure approximately an hour after birth, and after multiple failed helicopter transfer attempts, was eventually transferred to the Loma Linda NICU the following day via ambulance. The family scrambled to pick up Rudy's grandma at the LA airport, transport Rebecca, Rudy's mom, to be with Rudy at Loma Linda, and drop Grandma in Ridgecrest to care for Rudy's then 3-year-old sister Evy, all before Tom, Rudy's Dad, returned to be with his son, and Rebecca.

Rudy's 26-day stay in the NICU was eventful with a blood transfusion, a diagnosis of two heart defects, support for low muscle tone, and feeding challenges. He received assistance with calorie intake by way of a tube, which delivered Mom's precious breastmilk. Rudy also received oxygen around the clock in those first few weeks, as his body grew stronger, and

become more capable of supplying, and maintaining his own oxygen flow. On the 29th of March, Rudy had mastered the bottle, was breathing on his own, and was generally deemed strong enough to make the trek home to the high desert in Ridgecrest, CA. It was, however, determined that Rudy would need oxygen going over Cajon Pass, which has an elevation of approximately 4,000 feet. Rudy and his family loaded up in their Subaru, looking a bit like the Clampetts, after living in the Ronald McDonald house for nearly a month, and headed home to the sound of Rudy's oxygen desaturation bell dinging almost incessantly.



Fast forward a year later, and Rudy is thriving, thanks to having all his in-home therapy in place, and the support of an exceptional host of specialists at Children's Hospital of Orange County (CHOC). Included in Rudy's extraordinary therapy team is California-Hawaii Elks Major Project speech pathologist, Michelle Bychek, who travels over an hour each direction, to provide Rudy with feeding therapy, as well as speech therapy.

Thanks to Michelle's expertise, and experience, Rudy is devouring purees, and attempting to steal pizza slices, and sopapillas right out of his family's hands! Getting started was a bit intimidating for Rudy's family, as children with Down syndrome suffer from low muscle tone, which can affect everything in their bodies, including swallowing, resulting in a significantly increased likelihood for food and fluids being misdirected into the lungs rather than into the stomach. Being the parents of a child with special needs can be absolutely overwhelming, and it is extremely helpful, even critical, to have exceptional in-home therapy care. The California-Hawaii Elks Major Project Inc. is providing Rudy with a service he would likely not receive otherwise, as therapy resources are limited in Rudy's rather rural, and isolated high-desert community.



The early intervention speech pathology services that Rudy is receiving, through the benevolence of friends, and members of the Elks. are giving him the tools he needs to get ahead of the curve. These services maximize his chances of maintaining the ability to keep his lips closed and his tongue in a good position inside his mouth. That can be a challenge for many children with Down Syndrome, due to the impact of the condition on the body. He is gaining a rich preparation for soaring in his speech, and language skills, through the Elks generosity. The Elks of California and Hawaii stand behind, and around this little boy, invisibly, paving the way for a future in which he'll thrive.

Rudy's family feels that he is destined for success, with an active lifestyle, and a kind heart. Outdoor exploration, community involvement, and a lot of reading are among family focuses that will hopefully help Rudy to be a motivated, kind, and curious person. Rudy's sister was on her pedal bike prior to her third birthday, so Evy will be excited to help Rudy catch up on his Specialized Hotwalk bicycle, once he starts walking in order to enable the family to do more adventuring via bike. And, of course, eating is an American family tradition, so being able to anticipate Rudy sitting at the table, and eating the same meal as his family in the very near future, is a reality that is coming true thanks to Michelle and CHEMPI.



Rudy's family will be forever grateful for the immense impact the very generous members of Elks have had in their lives. As well as the lives of all the other children, and families who benefit from our Major Project here in California and Hawaii. If you all could see the joy on little Rudy's face when he sits in his high chair, and tries a new food, only then would you truly understand the significance of your seemingly small contributions. Rudy's family is immensely appreciative of your support of the Purple Pig, and of the thousands of children under your aegis so that they can walk, talk, see, play, EAT, and ride bikes!

Just a coin a day is all it takes to help children like Rudy!

The proceeds were donated to Huntington Beach Elks Charity program, with the condition that it be awarded to deserving children whose families are not receiving much in the way of other assistance. Isabella was a happy healthy child, until she had an incident, that resulted in her being diag nosed with Friedreich's Ataxia (FA). FA is a rare, inherited, neuromuscular, degenerative, genetic disorder/disease. It can cause difficulty walking, slurred speech and a lack of coordination, among other symptoms. Shortly after her diagnosis, she lost strength in her legs and has been in a wheelchair since 2021. One of Isabella's physical therapists suggested therapeutic horse riding as something that might assist Isabella. That is when the Orange Elks Lodge

stepped in to give Isabella a big therapeutic assist!

Huntington Beach Elks Motorcycle Club volunteered their services to Robyne's Nest. This is an organization in Huntington Beach that provides at risk and homeless students, who have little or no parental support, with resources to complete high school and pursue a path to self-sufficiency.

For the past several months the club volunteered their labor and skills, along with materials so a four bedroom home, that will house six teens and an on-site house manager, can open in the community. The work they provided includes: unloading a U-Haul truck full of household belongings, hanging blinds and curtains, installing kitchen/bathroom cabinet hardware, assembling beds, installing clothes organizers, raked and cleaned the homes landscape, and much more. There were thirteen volunteers who provided over three hundred volunteer hours, as well as \$1,500 in materials, and another \$500 in gift cards. The Lodge appreciates all that the club does for our community.

Orange Lodge 1475 and Make-A-Wish mission, is to grant the wishes of children with life-threatening medical conditions.

The Lodge met Zach Mauldin, a Make-A-Wish recipient. Zach was diagnosed with Thyroid Cancer. Zach is a senior at Canyon High School, and has earned the rank of Eagle in the Boy Scouts, and is a baseball fan. His Eagle project was to build a Hope Chest with board games for Make-A-Wish. The Hope Chest enabled Make-A-Wish to take games to their events.

Zachs Make-A-Wish was to meet Los Angeles Angels Mike Trout. Zach, and his family were picked up in a limousine, given a stadium tour, and then met Mike Trout, who was also able to introduced Zack to Shohei Ohtani.

It is now also the time of year when we begin entering our information into CLMS for the current year. You can put bookmarks, placeholders into the system for recurring events that you have upcoming such as your Flag Day, Mother's Day, 4th of July, and those types of recurring events that you have each year, and you can then go in later and fill in the information. Lodge Secretaries, again I cannot stress enough if you do not have the time to do these entries yourself, you can appoint a Charity Report Coordinator. The information is below on how to do that within the system. These numbers are very important to our Lodges and to our Order, to help us maintain our nonprofit status. It also allows us to show our local governments, and communities, see what we've done on the local, state, and national level, as far as our donations of members time, volunteer hours, and both cash, and non-cash donations towards our community services and charities. Thank you again for all your hard work this year, now we just need to bring it home.

Again, as promised, I am including these simple instructions to assist with getting the reporting entered. Lodge Secretaries, you do not have to do this all by yourselves. Get help! You can assign an assistant access to help with the reporting of our charitable works to help offload the Secretaries burdens. They will only have to access to do reporting on local charitable event data, nothing else in CLMS.

Step 1- Under the Staff Tab in CLMS, Appoint Local Charitable Report Coordinator

Step 2 - Select the name of individual on the drop down menu, select Appoint Local Charitable Coordinator

Just a reminder, that there is a Government Relations report

that is due monthly to the District Government Relations Chairman, who will the compile and send a monthly report to me and my Vice-Chairman, Alyssa Santos copying their DDGER and AVP. It is also now included in the new Grand Lodge Government Relations manual if you need a copy.

To those who donated in any way, thank you for helping to ensure that the Major Project continues beyond your lifetime.

Did any of you receive a gift, or bequest from a relative, or friend? Found money is good money...what about paying it forward by putting in a separate account with a payable on death ("POD") beneficiary designation to the Major Project? The funds are still there during your lifetime if you need them, and would then be paid to the Major Project on your death. My bank allowed me to add a POD beneficiary online...easy peasy. My suggestion is that if you do that, please let the Association know. My professional experience is that when someone dies, the Banks, or Brokerage houses will not share information with anyone but the POD beneficiary. Not wanting to share it with the Association? Let someone know, so that they can contact the Association on your behalf. POD beneficiaries can only be changed by you prior to death, but you should entrust someone with the information. By the way, not just bank accounts, most types of asset accounts can be set up this way. Kind of like the beneficiary on an insurance policy - but we talked about that last time.

It has been a pleasure to be the Chairman of BLT Legacy Giving for these past few years. I hope our columns have been helpful to you, and that they perhaps have helped you make a decision to provide for the Major Project in your Will, Trust, by beneficiary designation, or?

In early February 2024, members of the Elks met to judge the scholarship applications that had been forwarded to us by the Elks National Foundation. It was inspiring to know

that the 365 applications stacked on the table represented the best and brightest students in California and Hawaii. There were 2,209 students in California and Hawaii that had completed applications last fall and the applications we were reviewing had been judged at the Lodge level and then again at the district level. The Lodge and District Judges did an outstanding job of going through the applications and selecting a total of 365 applications for us to review at the CHEA Association level.

We made the commitment that we would judge fairly, objectively, and consistently. When the judging was completed, Seventy-three applications were selected to be forwarded on to the Elks National Foundation for the final selection of the Most Valuable Students. As we read the student essays and reviewed what the students had accomplished in their high school years, we quickly got the sense that they are leaders with a sense of purpose.

I want to thank Annette Adams and Julie Steele, from the CHEA Office in Fresno, for their help in coordinating the hotel rooms, and printing the 365 applications and the twenty-three members of the Elks that judged the applications. I want to thank Tim Martin for making space available at the CHEA Office in Fresno for us to use.

While all the college scholarships are currently closed, the California-Hawaii Elks Association provides Vocational Grants that are open to anyone residing in California or Hawaii, who is a citizen of the United States of America and planning to pursue an eligible vocational/technical (voc/tech) course resulting in a certificate or two-year degree and leading to employment opportunities. The program is open to male and female applicants who will be judged on an equal basis. While graduating high school seniors may apply, it is not limited to high school students-in fact, it is open to all prospective students who require training or retraining to compete in the workplace. The Vocational Grant is for one academic year, with an option to renew for one additional academic year. This grant may be used only for usual and required costs of a student's course of study; that is, for tuition and fees, room and board (if living on campus) and books and supplies. Payment will be made to the school. Awards will be between \$500 and \$2,000 for an academic year depending on the length of the course.

The definition of an eligible program shall be comparable to that contained in the federal vocational legislation. That is defined as a two-year or less vocational/technical program culminating in an Associate degree, diploma, or certificate, but less than a baccalaureate program (Bachelor's degree). Online and correspondence courses do not qualify.

In the last two years we have issued over 40 grants to people

wanting to study nursing, various medical programs, electronics repair, veterinary technician, barbering, mechanics, EMT, firefighting and a welding certification program. For more information, please go to the CHEA Website at: Scholarships -California-Hawaii Elks Association (chea-elks.org)

DEA Releases New Publications

The Drug Enforcement Administration recently released two publications entitled: Prescription for Disaster: How Teens Misuse Medicine and Preventing Marijuana Use Among Youth and Young Adults. You may guestion why the emphasis on Marijuana—especially since today cannabis is legal in California for both medicinal and adult (recreational) use. It is not legal for children under the age of 18 to use this or other drugs. Research published in 2022 by Oregon Health & Science

University found that adolescent cannabis abuse in the United States has increased by about 245 percent since 2000; a 2022 study by the Columbia University Mailman School of Public Health found that, in 2020, 35 percent of high school seniors and 44 percent of college students reported using marijuana within the past year. That study also found that vaping was increasing as the most popular method of cannabis use. Education plays a critical role in preventing substance abuse. Drugs of Abuse, A DEA Resource Guide, is another publication designed to be a reliable resource on the most commonly abused and misused drugs in the United States. This flagship outreach publication is a comprehensive guide that provides valuable information about the harms and consequences of drug use by describing a drug's effects on the body and mind, overdose potential, origin, legal status, and other key facts.

These new publications are available in both English and Spanish.

I want to thank my Vice-Chairman, Susan Good, for her help and support during the past years. I am pleased that she will be assuming the reins as DAP Chairman with Patricia Hamilton coming aboard as her Vice-Chairman. I know that they will do a great job in promoting the Drug Awareness Program—one of the most important programs in all of Elkdom, as it affects our youth of today and the future of tomorrow.
