The Mother Lodge of Tennessee, Memphis Lodge No. 27, was instituted in 1887. Back in the day when the Elks held their Grand Lodge Reunions in different cities, each Lodge would have a Convention Badge made, which would be traded with with fellow Elks, from other Lodges. CHEA Historian Lobdell presented a Reunion Badge from Memphis, the Mother Lodge of Tennessee, which came from the Grand Lodge Reunion, that was held in Atlantic City in 1911, to GER Shook.

Historian Lobdell went on to say, "Your Installation last year in Minneapolis, Minnesota as our Grand Exalted Ruler, was a momentous moment for you I'm sure. You have the distinction of being one of three, Grand Exalted Rulers ever to be installed in the city of Minneapolis, Minnesota, throughout the history of the Benevolent and Protective Order of Elks. The first Grand Exalted Ruler to be installed in Minneapolis was Grand Exalted Ruler Meade D. Detweiler in 1897. In honor of your visitation I would like to present to you, his Grand Exalted Ruler's ribbon from the Eleventh Annual Reunion in Minneapolis."

Hello fellow members!

I'm happy to report that as of the latest email from Grand Lodge regarding year end 2023/

2024 Membership Gain, the unofficial Overall and Top Three

Associations are as follows: Overall: +15,461

California-Hawaii: +3,764 New Jersey: +2,569 Arizona: +1,470

While these are unofficial, congratulations and well done!

In this article, I wanted to take a deep dive into orientation. This is a critical piece of the candidate process. Your orientation team and officers are the face of your Lodge, and they need to be passionate and enthusiastic. If you are not a part of this team, consider it! Even just being a positive person as candidates check-in for orientation adds to their experience.

The content of orientations should be no longer than an hour; longer than that, it's very difficult to retain attention. Have a variety of presenters. We've all been to a convention where a speaker droned on and on. Think about how quickly you tune out. The attention span of an adult is on average 8-10 minutes.

Exalted Rulers should make attending orientations a priority. Your enthusiasm can be contagious and when the leader of the Lodge asks for help, it's harder to say no. Would you say no if Association President Marty Mello asked you to help with something?

Have a sign-up list at orientation for volunteer opportunities. They're eager and excited to become members, ready to jump right in. They all said in their interviews that they want to give back; remind them of that! Partner new volunteers with positive members who can support them during their first volunteer experience, and not treat as an opportunity to spread negativity or raise internal politics. Think about the first time you volunteered, and why you came back a second time.

House Rules, go over them at orientation. We all have those rules that are specific to our Lodges. No hats on Fridays, collared shirts on Saturdays, whatever it may be. Share those important details, so that they don't get caught off guard later down the road, and have a negative experience. One thing Lodges often forget, and this goes with visiting elks also, is that new members and visitors are not mind readers. They are coming in blind and do not know all the rules. These are teaching moments and not chastising moments.

The same goes for bylaws and statutes, if I had a dime for every time someone told me new members do not know anything about being an Elk, I'd be able to pay for the upcoming 2025 Anaheim Association Convention. Of course, they don't know the statutes; they're brand new. One of the most common rules most new members don't know is that you have to have your physical membership card, and it must be signed. Give them some time to learn the ways of Elkdom and to learn the ways of your Lodge before judging.

Energetic and engaged Exalted Rulers, officers, and members are magnets for volunteers. Stay positive, be open-minded, and ask for help. No one wants to work with a jerk. The most successful Lodges have leaders that people just enjoy, and want to work with. Be the person you want to work alongside. Positive energy is key.

Lodge Learning Seminar's are coming! The first one will kick off on Saturday, August 10th at Sacramento 6 Lodge. I hope to see you all at one of the five opportunities across the Association between August and January 2025!

Greetings and Aloha!

You did it! We had a goal of all 164 Lodges submitting their Charitable Reports in CLMS and you did not let us down. 100% reported!!

Thank you to all of the Secretaries and Charity Report Coordinators for all of their hard work to get those figures entered for last year, and then review and finalize the report to Grand Lodge. Alyssa and I thank you very much!!!

We wanted to thank those of you who stopped by our Government Relations table at the CHEA Convention. It was wonderful meeting you and talking with you. We hope that we were able to give you valuable information to assist you, and your Lodge for the current Elks year. We were surprised at how many members did not know what can be reported into CLMS under the Charity report. All of you that attended the convention can submit your hours and miles to get reported, as we discussed Charity numerous times, and you all participated in some way. The same with your Lodge meetings and clinics as well. They all go under the "9999" Category for Categories Not Listed.

Some events that can be reported are: Flag Day, Mother's Day, Father's Day, 4th of July, Memorial Day, Bingo, Lodge Room Donations to Youth Groups such as Scouting, Scholarship Awards, First Responder Dinner, or Awards Night, Major Project Donations, ENF Donations, Veterans Activities, and many, more.

Our Lodge Charitable Donations for the fraternal year 2023-2024, totaled \$73,755,591. That was down over \$27 million from the previous year, with the biggest decline in Patriotic Programs.

Did you know that on average our Lodges nationwide, only report about 35% of what they could report on, whether it is hours donated or dollars given? Just think what our numbers would be if we increased that to say 50% or 60%. That would be huge!

We are asking all members, and committee chairmen, to fill out the Data Collection form, located in the back of the Government Relations manual, on page 19, Appendix Page 8, whenever they have an event at your Lodge, and turn it into your Lodge Secretary/Charity Report Coordinator for entry into CLMS.

Lodge Secretaries, again we cannot stress if you do not have the time to do these entries yourself, you can appoint a Charity Report Coordinator. The information is below on how to do that within the system. They will only have to access to do reporting on local charitable event data, nothing else in CLMS.

**Step 1**- Under Staff Tab in CLMS, Appoint Local Charitable Report Coordinator

**Step 2** - Select name of individual on drop down menu, select "Appoint Local Charitable Coordinator."

There is a Government Relations report that is due monthly to the District Government Relations Chairman, who will then compile and send a monthly report to me and my Vice-Chairman, Alyssa Santos, copying their DDGER and AVP. Now it is also included in the new Grand Lodge Government Relations manual if you need a copy.

Please feel free to reach out to me, or our Vice-Chairman, Alyssa Santos if you have any questions.

We look forward to seeing you at the CHEA Mid-Term Conference in November, which will be held in Burbank. We will have a table set up for our committee. If you have any questions, feel free to stop by and speak with us.

The purpose of the BLT fund/program is to ensure that there will always be funds available to continue the work of our CHEMPI therapists for our kids, if current funding falls short. In other words, we want to fund the program for our grand-children's children and beyond.

Our overall goal is to increase the amount of money that is left to the Major Project through our BLT programs. We will be taking several steps to achieve this goal. But most importantly, we want make sure that you, our members, know about the various BLT programs in which you can participate.

First, and the most common way to do so, is to name CHEMPI/Major Project as a beneficiary of your estate upon your passing. There are many ways to do this, and your estate planner can help you figure out what will work best for you.

Another way to donate, if you have a life insurance policy, is to designate CHEMPI as one of the beneficiaries of that policy. CHEMPI need not be the sole beneficiary; it can simply receive a portion of the insurance payment.

You can also donate directly to the CHEMPI/Major Project. Any money you donate over \$500 will automatically be placed into the BLT Legacy Trust Fund. While we like to recognize your gifts to support this program, if you wish to remain anonymous, you can. Just let the CHEA (California-Hawaii Elks Association) office in Fresno know and you will receive recognition, or not, depending on your wishes.

Finally, you can participate in the Commitment Trust program. We will detail this program in subsequent magazine editions. Robyn and I look forward to serving as promoters of the BLT and hope that you will also help promote these programs which are so vital to helping our kids walk, talk, and play.

A few years ago, the Elks National Veterans Service Commission began offering Boost Grants to Voluntary Service Representatives who planned projects that go above, and beyond their typical monthly activities. This grant was created to build on the experience that current Elks volunteers have, and the relationships they have formed with the veterans they serve everyday.

When the VA in Manila, Philippines requested blood pressure monitors to help veterans maintain their health after their appointments, Voluntary Service Deputy Representative Aaron Key stepped up to provide them. He continued the project this year with funding from a Boost Grant.

At the South Orange County Vet Center in Mission Viejo, Voluntary Service Representative David Perry decided to apply for a Boost Grant to provide therapeutic archery lessons. This activity makes a great addition to other recreational, and social programs Perry hosts, like lobster fishing trips, football watch parties, axe throwing, and other activities.
